

1. **Name of work:** Annual contract for the work of transportation of various EHV equipments/ material at 400 KV RS Dn, New Koyna.
2. **Estimated Cost:** - The estimated amount is **Rs.4,23,248/- (Including GST)**
3. **Validity of Offer:** - The rates should be valid for 60 days from the date of receipt of the quotations.
4. **Due Date:** - The SRM-enquiry should be submitted online on or before **01.04.2025 up to 18:00Hrs.**
5. **Submission of Bills & Payments:** -100% payment will be made after receiving of bills in triplicate. Payment will be effected at Division level as per availability of funds.
6. **Security Deposit:** - You will have to pay the security deposit of **10%** of the order value within Seven days from the date of receipt of LOA. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee (d) Cheque from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
7. The quotations not confirming to the specifications are likely to be rejected.
8. **Following attested documents should be attested with the quotation.**
 - 1) The Bidder should have valid proof for PAN/GST registration certificate
 - 2) The Bidder should provide proof of registration of firm under Bombay shop & Establishment Act.
 - 3) The Bidder should have valid Transport Contractors License.
 - 4) The Bidder should have Income Tax returns of the last financial years (i.e.2023-24).
 - 5) Certificate of performance of the above subjected work from an authority not below the rank of Executive Engineer equal or above Rs. 2 Lac.
9. No Crane will be provided by M.S.E.T.C.L.
10. All required T&P / Manpower will be at your cost.
11. The bidder is expected to visit the site before purchasing / submitting the bid document.
12. The MSETCL, after acceptance of contract will not pay any extra charges for lead or any other reasons, in case the contractor is found later on to have misjudged as available.
13. The contractor must arrange for all the transport of materials at site and include all such cost in the rates quoted by him for finished work. The contractor shall make his own arrangements for the transport of his materials.
14. A Schedule is included in the Enquiry document. It shall be definitely understood that the Company does not accept any responsibility for the correctness or completeness of this Schedule and this

- schedule is liable to alterations, omissions, deductions or additions at the discretion of the Executive Engineer, 400 KV RS Division, MSETCL, New Koyna, as set forth in the conditions of contract.
15. The rates quoted in the form of words by the bidder shall be taken as correct in case of dispute.
 16. The Enquiry documents shall be written legibly and shall be free from eraser, overwriting or conversions of figures correction and where unavoidable shall be made by crossing out initialing, dating and rewriting.
 17. The contract or any part thereof shall not be sublet without the written permission of the Executive Engineer, 400 KV RS Division, MSETCL, New Koyna.
 18. The taxes should be quoted separately; otherwise it will be presumed that your rates are inclusive of all.
 19. All the documents of this Enquiry, Schedule "A" and other accompanying documents shall bear the authorized signature of the bidder, failing which the offer will be liable for rejection.
 20. The bidder is in his own interest expected to visit the site of the work and acquaint himself with the site conditions and all other conditions which will affect the work.
 21. It shall definitely be understood that the MSETCL Company does not accept any responsibility for correctness and completeness of the Schedule of quantities, attached herewith and these are subject to alteration at the discretion of the undersigned.
 22. List of the similar works executed by the contractor elsewhere preferably with testimony from the concerned shall be attached with the documents if available.
 23. The documents of an offer shall be written legibly and free from erasures, overwriting or conversion of figures correction, where unavoidable shall be made by crossing out, rewriting, initialing and dating.
 24. Quotation which does not fulfill all or any of the above conditions or are incomplete in any respect is liable to be rejected.
 25. The right to reject all or any of the quotation without assigning any reason, whatsoever for the rejection of any quotation or all the quotations or to place an order for full quantity or part thereof or to finalize the order on time preferred basis or to split the order quantity wise is reserved with the undersigned.

TERMS AND CONDITIONS

1. **Security Deposit:** - You should pay security deposit equivalent to 10% of the value of the order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee (d) Cheque from nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
2. **Penalty:** -If you fail to carry out the work in the stipulated time as mentioned above, you will be liable to pay penalty 1% per delayed day subject to maximum limit of 10% of the total value of the order.
3. **Submission of Bill & Payment of Bill:** -The bills for the work as per Schedule 'A' should be submitted in triplicate, in the name of Executive Engineer, 400KV RS Dn, New Koyana should be submitted to the concern S/Dn. in-charge. The concern S/Dn. in-charge should submit the bill along with logbook (in-out entries with date & time, Kms, Fuel account, place of visit etc.) to this office. The contractor will be paid 100% payment of the bills, subject to any deductions against the contract after duly certified by the Company's Officer deputed /nominated in this behalf and within the reasonable period from the date of receipt of the satisfactory work completion report, through concerned Engineer-in-charge.
4. **Agreement:** -You have to execute Indemnity cum agreement bond on stamp paper of Rs.500/- in prescribed form for your cost.
5. If the order is not executed completely and satisfactorily it will be treated as cancelled and the work will be got done from the departments/ outside agency even at higher rates and the difference in the rate will be recovered from your pending bills if any or from security deposit paid to company.
6. **Income Tax:** - Income tax will be deducted @ 2% as per the rule on every monthly bill. Also, income PAN no. should be conveyed to this office. Further service Tax will be deducted at prevailing rate.
7. Not with standing anything stated here in, the Company's General Conditions of Contract shall be applicable to the contract, as far as they are applicable, in respect of this contract.
