- 4. The vehicle should be registered as a public service vehicle and is also covered by valid contract carriage permit.
- 5. The rates quoted should be mentioned along with inclusive or exclusive of service Tax & income Tax and the per day rate be quoted. Driver will be provided by the vehicle owner & his payment will be done by the vehicle owner as per act.
