**Terms & Conditions:-**

**1.Due Date:-** The prescribed form i.e. Schedule A duly filled in with the rates written in both numbers & numerals i.e. in words & figures; & duly signed & stamped by the signatory authority should reach this office on or before date 30/04/2025, at 18.00 Hrs to this office.

**2.Sealing & Super scripting:-** The offer should be sealed in sturdy envelope & should be super scribed by:-

- Subject of this enquiry
- T.O. Outward No. & outward date of this enquiry
- Due date of submission of this enquiry as mentioned in condition (1).

**3.Other Conditions:-** The offer should be submitted along with following conditions:-

- Rate validity of the offer
- Inclusion/exclusion of taxes
- Mode of payment.
- Any other condition from the contractor if so

**4.Security Deposit:-** The successful Bidder shall have to pay 10% of the contract value or in the form of bank guarantee or FDR towards security deposit within 07 days from the date of acceptance of this offer or it will be deducted from RA bill along with interest at 18% for concerned period. The amount will be refunded in the normal course, after expiry of the contract guarantee/warrantee period subject to deduction, if any. If you fail to apply within stipulated period, the action as per company's rules will be taken

**5.**The work is to be carried out as per requirement and specifications. The guarantee certificate for supplied material should be submitted along with bill.

**6.Interest:-** No interest will be allowed on this S.D. On the breach of contract during contract period, S.D. will be forfeited without assigning any reason

**7.Rate Validity: -** The offer shall be valid for acceptance for a minimum period of 60days from the date of submission of the offer. During this period no bidder shall be allowed to withdraw his offer. Such withdrawal within said period shall result in the forfeiting of SD.

**8. Period of Order:** - The work is to be carried out within 30 days from the date of issue of Order.

**9. Document Authorization:** - All the supporting & accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection.  
**Also enclose the registration copy of Shop Act, GST Registration details, Certificate of authorized dealership if any and PAN card**

**10. Penalty:** - If the offered work is not completed within the allocated period, then penalty @ ½ % of the order value maximum limited to 10% of the order value shall be recovered from the claims of the contractor.

**11.** The material supplied should be as per the requirement & specification. Quality material should be supplied. Any defect observed in the material supplied by you, the same shall be replaced by you free of cost without delay.

**12. Payment:** - Payment along with applicable GST shall be made after completion of work, due recording and scrutiny of the bill by EHV Project Circle, Pune.

**13. Tax Deduction:** - Income Tax (Or whichever is applicable as per the Govt. statutory rules) at source will be deducted from the contractor's bill. The Income Tax registration no. if allotted should be informed to this office. The Xerox Copy of PAN card should be attached with the bill.

**16. Right of acceptance/rejection:** - The undersigned reserves the right to continue or terminate the offer without assigning any reason thereof.


**17.** Jurisdiction of all suits/ legal proceedings in regards to work against this tender order thereof shall be subjected to the court of Pune.
