- 1) Name of work: **Providing diesel vehicle (TATA SUMO/BOLORO/Utility Vehicle equivalent or above) with driver on hire basis for 312 days (01 Year) for Addl. Ex. Engineer, Communication Unit, Sangli under PAC Division, Sangli.**
- 2) The vehicle must be with RTO Tourist permit valid for a period of contract i.e. from actual engaging the vehicle (01 Year)
- 3) Only Diesel will be supplied by the MSETCL.
- 4) Total budget of order is limited up to Rs. **5,43,000/-** (Inclusive of all taxes)
- 5) The vehicle will be utilised on any day throughout the contract period as per the requirement of Addl. Ex. Engineer, Communication Unit, Sangli.
- 6) You will have to pay the security deposit of 5% of the order value within seven days from the date of receipt of LOI/order. Also, agreement on stamp paper of Rs 500/- should be submitted after the receipt of LOI/order. Cost of stamp paper shall be borne by agency.
- 7) The quotations should reach to this office **on or before 08.05.2025 up to 16:00 Hrs.**
- 8) Vehicle model should be within 5 years or with good condition if earlier.
- 9) **FASTag**, India's electronic toll collection chip for all national highways is mandatory.
