#### In this fee structure:

$\square$ ,,C" type of contractor would only eligible to participate in the ,,c" type tender (i.e. value up to Rs. 50 Lakhs.)
□ "B" type of contractor would eligible to participate for both "C" & "B" type of tenders.
(i.e. value from Rs. 0 to 2 crores)
□ ,,A" type of contractor would be eligible to participate for all types of tenders.

In case if any bidder / contractor wish to participate in higher level of tender value than that for which he has registered, he will have to pay the difference of registration fees for which he wish to participate.
