

**RESULTS OF THE RECRUITMENT FOR THE VARIOUS POSTS OF FINANCE AND ACCOUNTS CADRE ADVERTISED VIDE ADVT. NO. 08/2009 DURING NOVEMBER, 2009.**

- 1) An advertisement for filling in the various posts of Finance & Accounts Cadre i.e. Assistant General Manager, Sr. Manager, Manager and Deputy Manager was published in the month of November, 2009. The Written Test was conducted on 13.12.2009 and personal interviews were held on 08.02.2010 & 09.02.2010 at Mumbai.
- 2) The list of successful candidates for the various posts of Finance & Accounts Cadre i.e. Assistant General Manager, Sr. Manager, Manager and Deputy Manager is given below.
- 3) **For the post of Assistant General Manager(F &A), no candidate has been qualified from ST & SC Category. Similarly, for the post of Manager (F &A), no candidate has been qualified from VJ-A Category and for the post of Deputy Manager (F&A), no candidate has been qualified from ST category.**
- 4) While drawing select list, out of 150 marks obtained in Written Test have been converted into 90 marks and out of 50 marks obtained in personal interview have been converted into 10 marks. Thus merit list has been drawn out of 100 marks.
- 5) The select list is drawn in order of merit by adding interview marks to the Written Test marks of qualified candidates on the basis of aggregate vis-à-vis vacancies advertised and anticipated during the year.
- 6) The reserved category candidates who have been selected on merit are treated as selected against 'open category'.
- 7) The reservation for the physically handicapped persons and women has been considered.
- 8) Selection of female candidates against Women reservation is subject to production of non-creamy layer certificate from the Competent Authority, if not submitted along with application.
- 9) Likewise selection of Backward Class Candidates is subject to production of Caste Validation / Verification Certificate from the Caste Scrutiny Committee, if not submitted along with application.
- 10) The select list will not confer any right on the candidates for immediate appointment as the select list is meant for the entire year i.e. 2010. As such, the appointment letters will be issued taking into account availability of vacancies, reservation for backward classes etc.
- 11) In respect of departmental candidates their appointment shall be subject to verification of disciplinary action / vigilance report if any.
- 12) **The selection of the candidates is purely on provisional basis subject to conforming of the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, his selection is liable to be cancelled.**
- 13) While every care has been taken in preparing the results, MSETCL reserves the right.
- 14) The decision of the Company shall be final and no individual representation/correspondence will be entertained.
