Candidate should note that their candidature shall stand cancelled and they will not be allowed to appear for the personal interview, unless they produce all the required documents for verification before interview.
- 2. Candidates appearing for interview should ensure that they satisfy all the conditions including QUALIFICATION & EXPERIENCE as notified in the Advertisement.
- 3. The experience certificate should contain details like exact period, nature of duties done / experience gained, emoluments drawn, reasons for leaving, etc. duly signed by the employer.
- 4. Any request for change of time, date and/or venue of the interview will not be entertained under any circumstances.
