

INTERVIEW SCHEDULE FOR THE POST OF EXECUTIVE ENGINEER (TRANS), DY. EXECUTIVE ENGINEER (TRANS) & DY. EXECUTIVE ENGINEER (CIVIL) AGAINST ADVT. NO. 3/2011 OF MSETCL

- I) The written test for the post of E.E. (Trans), Dy. E.E. (Trans) & Dy. E.E. (Civil) against Advt. No. 3/2011, was held on 29.05.2011. Thereafter representations were received from some of the candidates about the written test for the post of E.E. (Trans) & Dy. E.E. (Trans) stating that there were wrong / out of syllabus and repeat questions in the question paper. Further it was stated in the representations that the questions were taken from the particular book. After receipt of the representations, it was decided to constitute a Committee consisting of two experts from the side of Recruiting Agency & two experts from MSETCL side to examine the issues raised in the representations. Accordingly, the Committee examined the issues & submitted its report. It was noted that quantum of wrong questions / out of syllabus / repeat questions was meager. After considering the report & recommendations of the Committee it was decided that the wrong / out of syllabus questions will be ignored & equivalent marks shall be added to all candidates and repeat questions will be evaluated as per regular evaluation procedure.
- II) Accordingly, assessment of the answer sheet was done & taking into consideration the performance in the written test, the candidates have been short listed for personal interview.
- III) In the meantime, due to administrative reasons vacancies for the post of Dy. E.E. (Trans) & Dy. E.E. (Civil) against quota of direct recruitment have also been revised as below:

INSTRUCTIONS

1. Candidate should bring the call letter for interview along with **2 recent passport size photographs** and all **original** Certificates regarding Educational Qualifications (i.e. degree certificate & statement of marks), Experience, Age, S.S.C. Certificate, Caste Certificate, Caste validity certificate, Non-Creamy Layer Certificate, Domicile Certificate, Sports Certificate, Medical Certificate from appropriate authority showing disability for PH person, etc., whichever is applicable together with **one attested true copy of each of these certificates** at the time of interview. **Candidate should note that their candidature shall stand cancelled and they will not be allowed to appear for the personal interview, unless they produce all the required documents & unless satisfy that they fulfill all criteria of eligibility required for the above-mentioned post as mentioned in the Advt. No. 3/2011.**
2. If candidate belong to Backward class category other than SC & ST, he should produce a Certificate from appropriate authority as prescribed by Govt. of Maharashtra vide Circular No. CBC-10/ 2006/PK 15/ BCR-5 dated 5/6/2006 showing that he is not covered under Concept of Creamy Layer.
3. The unemployed reserved category candidates namely SC, ST, VJ(A), NT-B, NT-C, NT-D and Spl. BC will be given reimbursement of traveling expenses equal to the second class rail fare (without reservation charges) or ordinary S.T. bus fare from the place of their residence to the place of Interview and back (limited to journey performed within the State of Maharashtra) on production of original/photocopy of the Rail/S.T. bus fare tickets alongwith copy of caste certificate/non-Creamy Layer Certificate wherever applicable issued by the appropriate Competent Authority, as per Govt. rules as amended from time to time. However, local journey charges shall not be reimbursed.
4. **Candidates appearing for interview should ensure that all the conditions including QUALIFICATION & EXPERIENCE as notified in the Advertisement are fulfilled by him.**
5. **The experience certificate should contain details like exact period, nature of duties done / experience gained, emoluments drawn, reasons for leaving, etc. duly signed by the employer.**
6. Any request for change of time, date and/or venue of the interview will not be entertained under any circumstances.
7. If the interviews are not completed on the aforesaid date, the same will be continued/held on the next day. Therefore, candidates are requested to come duly prepared for the same at their own cost.
8. Any canvassing by or on behalf of the candidate or to bring political or other outside influence with regard to his selection/recruitment for the above post shall be considered as **DISQUALIFICATION**.
