### OFFICE ORDER NO 294.

On the recommendations of the Competent Selection Committee and in pursuance of the approval accorded by the Competent Authority in exercise of the powers delegated to him under Schedule III, IV & V appended to the MSEB Employees' Service Regulations, Miss. Sheetal Chintaman Gedam, (02471728) Manager (HR) working at EHV O&M Circle, Kalwa under EHV CC O&M Zone, Vashi is hereby appointed as Senior Manager (HR) under Direct Recuitment against the post reserved for ST on temporary basis in the pay sclae of Rs. 21170-845-25395-900-47895 and posted to work at Technical Establishment, HR Depratment, Corporate Office, Mumbai against the vacant post of Senior Manager (HR).

- The pay of Miss. Gedam shall be fixed in the pay scale of Rs. 21170-845-25395-900-47895 as per S.R. 29(a) {read with S.R.32(b)} of MSEB Employees' Service Regulations from the date of joining as Senior Manager (HR) in persuance of this order.
- 3. Miss. Gedam is held eligible for transfer TA., Pay Advance, Joining Time etc., as per Company's Rule.
- 4. Miss. Gedam will have to pass the departmental Marathi Language Examination within three years as provided under the GSO 117 dated 30.06.1962 and departmental Higher GAD Examination within three years or within four consecutive chances whichever is earlier from the date of joining in the post as provided under the GSO 110 dated 25.01.1962 read with MSEB Employees' Service Regulations as amended from time to time failing which her increment shall be withheld unless pass / exempted from passing both Marathi Language and HGAD Examination as per the rules. Further, she fails to pass the departmental Higher GAD Examination within stipulated time, the seniority will be reckoned from the date of passing the Examination.
- 5. She should communicate her acceptance or resfusal to the appointment as the case may be within 10 days from the date of receipt of this appointment order failing which it will be presumed that she is not intrested in the said appointment and her appointment order shall stand cancel which may be noted.
- 6. Miss. Gedam, Manager (HR) shall be releived immediately by making local arrangement but in any case on or before 09.12.2011. Her salary shall not be drawn at presnt place of working after 09.12.2011.
