2. Terms and Conditions

a. Their promotions are on provisional basis without prejudice to claims and seniority of others if any.

b. Their promotions are subject to outcome/decision in the Writ Petition No.8452/04 filed by Shri. Vijay Ghogare & Others v/s the State of Maharashtra and others in the High Court of judicature at Bombay.

c. Their promotion as **Manager (F&A)** shall be effective from the date of their joining as **Manager (F&A)** in pursuance of this order.

d. The above promotees shall draw pay in the pay scale of Rs. 19810-780-23710-845-43990 in accordance with the provisions of S.R.29 (a) read with S.R.32 (b) of the MSEB Employees' Service Regulations. However, in respect of such of the promotees who have already been granted the higher grade benefit of the post of **Manager (F&A)/Senior Manager (F&A)** under the provisions of G.O.74(P) dt.30.04.1974, their pay shall not be re-fixed again in the promoted post.

e. The above promotees are held eligible for Tr. TA, Pay advance, joining time etc., as per Company Rules, if there is change of Head Quarter.

f. The promotees should communicate their acceptance or refusal of promotion as the case may be within 3 days from the date of receipt of this order. The refusal of promotion will not make the promotees entitled to claim retention at the same place on the grounds of refusal of promotion and liable for transfer in the same capacity.

g. In case they refuse promotion to the post of as **Manager (F&A)**, the benefit of next higher grade of the post of **Manager (F&A)/Senior Manager (F&A)**, if granted to them on 1st and 2nd occasion shall be withdrawn from the date of promotion order in terms of the provisions under G.O.74 dt.30.04.1974.

h. The detailed posting order shall be issued by the concerned Chief Engineer

3. The promotees should be relieved immediately by making local arrangement but in any case before 13.09.2011. Their salary shall not be drawn at present place of working after 13.09.2011.

4. Their relief / joining report should be sent to the concerned establishment groups in Corporate Office, accordingly.
