- The selection of the candidates is purely on provisional basis subject to conforming of the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, his selection is liable to be cancelled.
- The select list will not confer any right on the candidates for appointment. All rights reserved to CE, EHVCC O&M Zone, Nashik.
- **The candidate shall report to the office of Chief Engineer, EHV CC O&M Zone, Nasik on 29-11-2010** along with original documents. On reporting they will be allotted to respective office under the jurisdiction EHV O&M Zone, Nasik, as per vacancy and reservation position. The appointing Authorities will issue appointment letter with detailed Terms & Condition and posting order.
- The reserved category candidates who have been selected on merit are treated as selected against open category.
- Maharashtra State Public Services (Reservation for Scheduled Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Class and Other Backward Classes) Act.2001 has been enforced by the Govt. of Maharashtra from 29th, January, 2004. As per the provisions under sub-section 2 (ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Schedule Castes and Scheduled Tribes i.e. VJ (A), NT (B), NT(C), NT(D) SBC & OBC category. The candidates should produce a caste certificate from appropriate authority as prescribed by the Govt. of Maharashtra vide Circular No. CBC-10/2006/PK15/BCR5 dated 5/6/2006, showing that they are not covered under the concept of "Creamy Layer".
- As per Administrative Circular No. 195 dtd. 05.01.2010 and Corporate Office letter No. Mahatransco/CO/HR/BCR Cell/1778 dtd. 04.02.2010 , the candidates for claiming the benefit of reservation under SC, ST, VJA, NTB, NTC, NTD, Spl.BC & OBC categories, they should produce a caste certificate along with **caste validity certificate** issued by Caste Scrutiny Committee at the time of reporting otherwise no allotment letter will be issued to B.C candidate and their candidature will be treated as cancelled. In case of ST category candidate the condition of cast validity certificate was already notified in advertisement.
- The reservation for the physically handicapped persons, Ex-Servicemen and women etc. has been considered.
