2. The on-line test (Examination) is scheduled on **19.09.2017.** Details of Venue, Time, Roll No, etc for the on-line test are given on the call letters. The call letters for on-line test are being sent on the e-mail ID provided by the candidates in the Application Form.

3. All the candidates whose applications received in prescribed format as per conditions in advertisement on or before last date of application i.e. 06.06.2017 are called for on-line test without verifying their eligibility.

4. In case of non-receipt of the call letter, candidates may contact at **022-26595228 & 022- 26595278.** Candidate may also write an e-mail to **callletter\_helpdesk@mahatransco.in** The said e-mail ID will remain active till 17.09.2017 (up to17.00 hours)

## Instructions for appearing Examination (On-line Test):-

5. Candidates are informed to bring hard copy/print out of call letter alongwith **currently valid Photo identity proof (as mentioned below) in original and a photocopy** of the same ID proof, which is essential. The call-letter alongwith photocopy of photo identity proof duly stapled together is required to handover to the invigilator before starting of on-line test. **Candidate's name as appearing on the call letter shall exactly match with the name as appearing on the photo identity proof.** 

6. The currently valid photo identity proof may be 'PAN Card/ Passport/ Driving License/ Voter's Card/ Bank Passbook with photograph/ Photo Identity Proof issued by a Gazzetted Officer on official letterhead/ Photo Identity Proof issued by a People's Representative on official letterhead/ valid recent Identity Card issued by a recognized college/ university/ Aadhar card with a photograph/ E-adhar card/Employee ID/ Bar Council Identity card with photograph"

7. **IDENTITY VERIFICATION:-** In the examination hall, the call letter along with a photocopy of the candidate's photo identity proof (as mentioned in 6 above) should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter and in the Attendance List. If identity of the candidate is in doubt the candidate may not be allowed to appear for the examination (on-line test).

8. For Female candidates:- Their names as appearing on the Call Letter (provided by them in Application Form) should exactly match with the name as appearing on the Photo Identity Proof. Female candidates who have changed first / middle / last name post marriage must take special note of this. If there is any mismatch between the name indicated in the Call Letter & Photo Identity Proof, that female candidates will not be allowed to appear for on-line test.

9. Candidates should report at examination Centre as per the reporting time mentioned in the Call Letter. Candidates reporting late for whatsoever reason i.e. after the reporting time specified on the call letter for examination (on-line test), will not be permitted to appear for the examination (on-line test).

10. Candidates will have to appear for examination (on-line test) at Examination Centre at their own risks and MAHATRANSCO will not be responsible for any injury or losses, etc of any nature.
