

Employment Notification No. 05/2017

The Maharashtra State Electricity Transmission Company Limited (MAHATRANSCO) invites applications from the Officers on deputation basis from amongst departmental officers from feeder post having two years experience or officers from sister concerns who are holding either position at same level or position of feeder category post of at least for a period of two years for the post of the <u>Chief General</u> <u>Manager (F&A)</u> on deputation basis, for the maximum period of three years or till attaining age of 58 years whichever is earlier.

1. <u>NO. OF VACANCY</u>: - One (Unreserved)

2. ELIGIBILITY CRITERIA AS ON: 28.11.2017

Eligibility condition	Departmental officers from feeder post having two years experience or officers from sister concerns who are holding either position at same level or position of feeder category post of at least for a period of two years.
Method of filling the post	On deputation basis
Period of Deputation	The tenure/period of Deputation shall be maximum of 3 years, counted from the date of joining of deputationist or till attaining the age of 58 years whichever is earlier.

3. <u>Compensation:-</u>

- i. The selected candidate will be drawing salary in the pay scale of **Rs. 45900-1950-88800/-**
- ii. In addition to this, he/she would be entitled to Dearness Allowance as applicable on the Basic pay and revised from time to time and other allowances/perquisites applicable to the post.
- iii. The selected candidate would also be entitled for HRA, Medical benefit, CPF, etc. as per Company's Rules.
- iv. In addition, company's or hired Car, Mobile Phone, etc. will be provided for official use as per Company's Rules.

4. <u>Residential accommodation:</u>

Residential accommodation can be provided as per Company's Rules, if available.

5. <u>Date of Birth:</u>

Date of birth shall be considered from passing certificate of SSC or as per School leaving certificate or Service Book entry of the Officer maintained in that Organization/Company.

6. <u>Methodology of Selection:</u>

- i. The selection process shall on the basis of Personal Interviews. However, which selection process is to be adopted will be at the absolute discretion of the company and the decision of the company in this regard shall be final.
- ii. The call letter for selection process will be forwarded through e-mail on the email ID as mentioned in the application form by the candidate.
- iii. The short listed candidates will have to appear for the selection process at their own cost. Traveling expenses will not be reimbursed.

7. <u>Application Fee:</u> Rs. 800/-

- i. Candidates shall furnish **Demand Draft (Having CTS Code)** towards application fee of **Rs.800/-** payable to the "**Maharashtra State Electricity Transmission Company Ltd.**" drawn on any **Nationalized Bank payable at Mumbai.** The candidate should write his / her Full Name & Post Applied on the backside of Demand Draft.
- ii. The Demand Draft submitted without CTS code will not be accepted and application may be rejected on the ground of non-submission of application fees in prescribed manner.
- iii. Fees in the form of Cheque/Postal Order/Money order/Cash or any other form other than Demand Draft will not be accepted.
- iv. In case candidate pays less fees than applicable fees, he/she shall be held not eligible.
- v. The fees once paid will not be refunded for any reason.

8. <u>How to apply:</u>

- i. Applicant should submit his application through his Controlling Officer.
- ii. Application must be submitted in the Proforma given with this notification in a same order preferably typewritten on fullscape paper. All items of the application should be filled properly.

- vi. Applications received after due date (for whatsoever reason) shall not be entertained. The Company is not responsible for postal delay or non-receipt of application within stipulated time. No correspondence in this regard shall be entertained.
- vii. Incomplete application, application without signature & without original Demand Draft and those not supported by attested copies of relevant certificates may liable to be summarily rejected. Copies of certificates should be duly attested.
- viii. While applying for the post, if required, candidates may attach a separate sheet duly signed in the same format as given in the application form showing the detailed experience such as name of Organization, designation/post held, nature of work, etc for various positions of working indicating specific period therein.
