# Employment Advertisement No. 13/2024 For the post of Chief Engineer (Transmission)

#### 1. COMPANY PROFILE:

Maharashtra State Electricity Transmission Company Limited (MAHATRANSCO), a wholly owned corporate entity under the Maharashtra Government, was incorporated under the Companies Act, in June, 2005 after restructuring the erstwhile Maharashtra State Electricity Board to transmit electricity from its point of Generation to its point of Distribution. It owns and operates most of Maharashtra's Electric Power Transmission System. MSETCL operates a transmission network of 51,518 Circuit KM of transmission lines and 742 EHV Substations with 1,38,598 MVA transformation capacity. This infrastructure constitutes most of the inter regional as well as intra-regional electric power transmission system in the State. Today, MSETCL is the largest state transmission utility in the country.

#### 2. POST, VACANCY & RESERVATION DETAILS:

2.1 MSETCL invites applications from experience, dynamic, talented and professional persons for following post:

2.2 The number of vacancies and category is provisional and may vary. Such change will not be notified either in Newspaper, on website or intimated to the candidate.

#### 3. PAY SCALE:

- 3.1 The selected candidate will draw salary in the pay scale of **Rs. 140655-5980-272215.**
- 3.2 In addition to basic pay, the selected candidate will be entitled to DA, HRA, Medical Benefits, CPF, Gratuity etc. as per Company's rules. Candidates may also be provided office quarter as per Company's rules, in lieu of HRA, if required by candidate and if available.
- 3.3 In addition, Company/Hired vehicle, telephone reimbursement, etc. will be provided for official use, as per Company's rules.
- 3.4 The approximate Monthly Gross Emoluments (without Office Accommodation) for the post of Chief Engineer (Transmission) shall be **Rs. 2,92,789/-**.

#### 4. **QUALIFICATION & EXPERIENCE:**

4.1 The candidate should possess following educational qualification and experience:

- 4.2 The departmental candidates of MSETCL possessing Degree in Engineering/Technology in any other discipline and who fulfill the condition of required experience will be considered provided that they will have to appear for in-basket exercise, Group Discussion, etc. consisting of syllabus of Electrical Engineering and compete along with other candidates.
- 4.3 A Degree should be from a University or Institute in India, established or incorporated under Central Act or a State Act or any other qualification recognized as equivalent thereto.
- 4.4 The *experience means Post Qualification experience*, i.e. experience acquired by the candidate after possessing the essential qualification prescribed for the post.

### 4.5 **Power Transmission Experience means:**

- a. Power Transmission experience means experience of Operations and Maintenance of EHV / HVDC Substation and/or Lines / Construction of EHV /HVDC Line and/or EHV /HVDC Substations / Design Engineering of new EHV / HVDC Lines and/or Substations / Management of Load of EHV / HVDC Network/ Operation and maintenance of EHV Substation attached to Power Generation Plant.
- b. "The term EHV Means 66 kv and above voltage level".
- c. For the purpose of consideration of experience in area of power transmission, the experience of a company having paid up capital of Rs. 100 Crores or more and having Power Transmission Business as its core activity/ Central, State Govt. Power Transmission Utilities/any company which has obtained Licensee from respective State Electricity Regulatory Commission as Private Power Transmission Licensee shall only be considered.
- d. The experience certificate issued by Private Contractors, Proprietors, etc. shall not be included as a Power Sector as well as Power Transmission experience. The experience certificate in respect of the company/organization other than Central, State Govt. Power Transmission Utilities submitted by candidate shall be self-explanatory i.e. in the experience certificate, area / nature of work shall clearly be mentioned so as to enable to decide his / her eligibility and there shall not be any ambiguity for deciding their eligibility.

- 4.6 Equivalency of outside candidates (other than MSETCL employees) will be compared / decided on the basis of gross emoluments drawn and job responsibilities.
- 4.7 The Qualification and Experience shall be considered as on **24.12.2024**.
- 4.8 Candidates should submit self-attested copies of certification for proving educational qualification and experience along with application form.

#### 5. AGE LIMIT:

- 5.1 The upper age limit for outsider candidate is 50 Years for OPEN Candidates.
- 5.2 The upper age limit for outsider candidate for Reserved Category and EWS Candidate applying for reserved vacancy is relaxable upto 55 years.
- 5.3 The upper age limit for departmental candidates (only MSETCL Employees) is 57 years.
- 5.4 Date of birth as per SSC/School leaving certificate should be mentioned in the Application Form. The age will be considered as on **24.12.2024**. i.e. last date of submission of the application.

#### 6. **RESERVATION**:

- Candidates claiming the benefit of reservation under backward class **should submit** a **Caste Certificate** issued by Competent Authority of GoM. Further, on selection, they will have to submit copy of **Caste Validity Certificate** issued by the Caste Scrutiny Committee if available with them. However, if candidate do not possess Caste Validity Certificate, on selection, an appointment order will be issued to them as per the provisions prescribed in सामान्य प्रशासन विभाग, महाराष्ट्र शासन, शासन निर्णय क्र.बीसीसी-२०९/प्र.क्र.२९१/०९/१६-ब दि. ०५.११.२००९ सह वाचावे बीसीसी-२०११/ प्र.क्र.१०६४/२०११/१६-ब दि. १२.१२.२०११.
- 6.2 The Caste Certificate issued by appropriate Competent Authority of Maharashtra State shall only be considered as valid for availing the benefit of reservation including application fees.
- 6.3 Backward Class candidates viz. Scheduled Caste candidates should be of the categories notified by the Maharashtra State (including SC category person who has adopted Baudha Religion).
- 6.4 The reservation for **Economically Weaker Section** of Maharashtra State has been indicated as per the provision prescribed in सामान्य प्रशासन विभाग, महाराष्ट्र शासन, शासन निर्णय क्र.राआधो-४०१९/प्र.क्र.३१/१६-अ दिनांक ३१.०५.२०२१. Candidates claiming the benefit of reservation under Economically Weaker Section category will have to submit **Domicile Certificate** of Maharashtra State issued by Competent Authority of GoM as prescribed in said Government Resolution and **Economically Weaker Section Eligibility Certificate** valid for Financial Year 2024-2025 or should submit receipt of submission of application for getting required Domicile Certificate and/or EWS Certificate from the prescribed Government Authority along with application form. valid on the date of eligibility i.e. **24.12.2024**.

- 6.5 The desired candidates, should claim the benefit of reservation clearly and absolutely in application form itself. If not claimed, it shall not be considered at any stage later on.
- Once the caste is notified in application form, it cannot be changed at any stage later on. The Backward Class candidates who apply against Open category will not be permitted to change the option once exercised at any stage later on.
- 6.7 Those reserved category candidates who have applied against Open Category & compete with the Open Category candidates will be treated as Open category candidate for the purpose of recruitment/selection process. However, if any such departmental reserved category candidate who have entered in MSEB / MSETCL by taking the benefit of reservation earlier, he/she will have to submit the caste certificate & caste validity certificate from Competent Authority before appointment, if selected even though he/she may be applying under Open category against this advertisement.
- 6.8 The candidates who desire to avail benefit of **Divyang** will have to submit **Medical Certificate** issued by the appropriate Medical Board in terms of Government of Maharashtra Resolution No. अप्रवि-२०१८/ प्र.क्र. ४६/ आरोग्य-६ दिनांक १४.०९.२०१८ read with शासन निर्णय क्र. दिव्यांग-२०१८/प्र.क्र.११४/५६-अ दिनांक २९.०५.२०१९ and other issued from time to time at the time of document verification. The Medical Certificate should be valid on the date of eligibility i.e 24.12.2024.
- 6.9 For claiming the benefit of reserved vacancy, candidates should submit self-attested copy of Domicile Certificate, Caste Certificate, Caste Validity Certificate (if available), EWS Eligibility Certificate issued by the appropriate Authority of Government of Maharashtra alongwith application form. Any shortfall of documents will not be considered on later stage of recruitment process. Hence, candidate claiming for reservation shall ensure that they have attached all requisite documents alongwith their application form.
- 6.10 It will be the responsibility of the candidates to produce all the required original documents/certificates for proving his/her eligibility at the time of documents verification, failure to produce the same may lead to disqualification.

#### 7. METHODOLOGY OF SELECTION:

- 7.1 Normally Competency Mapping Test will be conducted for selection process which will comprise of In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill and Personal Interview. However, which selection process is to be adopted will be at the absolute discretion of the Company and the decision of the Company in this regard shall be final.
- 7.2 The application received by <u>24.12.2024</u> will only be considered. Out of which the candidates who are apparently eligible as per age, educational qualification and experience shall be called for first four tools of Competency Mapping Test viz. In-Basket Exercise, Group Discussion, Case Discussion and Presentation Skill without verifying their other eligibility criteria.

- 7.3 The candidates will be shortlisted for Personal Interview in the prescribed ratio taking into consideration their performance in the In-Basket Exercises, Group Discussion, Case Discussion and Presentation Skill as well as after verification of their eligibility as mentioned in the advertisement.
- 7.4 The call letters to shortlisted candidates will be forwarded through e-mail id mentioned in their application forms.
- 7.5 Taking into consideration, overall performance reflected in all five tools of Competency Mapping Test viz; In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill & Personal Interview, the final select list shall be prepared.
- 7.6 The list of candidates shortlisted for Competency Mapping Test, Personal Interview and finally selected candidates will be displayed on the website.

- 8.2 The Candidates shall furnish application fee in the form of **Demand Draft** (**Having CTS Code**) payable to the "**Maharashtra State Electricity Transmission Company Ltd.**" drawn on any **Nationalized Bank payable at Mumbai.** The candidate should write his / her Full Name, Advertisement No. & Post Applied on the backside of Demand Draft.
- 8.3 Fees in the form of Cheque / Postal Order/Money order/Cash or any other form other than Demand Draft will not be accepted.
- 8.4 The Demand Draft submitted without CTS code will not be accepted and application may be rejected on the ground of non-submission of application fees in prescribed manner.
- 8.5 In case candidate pays less fees than applicable fees, he/she shall be held not eligible.
- 8.6 The fees once paid will not be refunded for any reason.

#### 9. HOW TO APPLY:

9.1 Application must be submitted in the Proforma given at the end of this advertisement, in same order preferably typewritten on fullscape paper. All items of the application should be filled in properly. Any changes in prescribed proforma is not allowed.

- 9.4 Candidates are advised to keep one set (photocopy) of all the documents (including copy of application form, DD) with them as a proof.
- 9.5 Applications received after due date (for whatsoever reason) shall not be entertained. The Company is not responsible for postal delay or non receipt of application within stipulated time. No correspondence in this regard will be entertained.
- 9.6 Incomplete application, application without signature & without Original Demand Draft and those not supported by attested copies of relevant certificates are liable to be summarily rejected. The duly self attested copies of certificates should be submitted along with Application form.
- 9.7 The departmental candidates of MSETCL have to submit post wise experience certificate of MSEB/MSETCL duly signed by the authority of MSETCL not below the rank of Executive Engineer.
- 9.8 While applying for the post, if required, candidates may attach a separate sheet duly signed in the same format as given in the application form showing the detailed experience such as name of Organization, designation / post held, nature of work, etc. for various places of working indicating specific period therein.
- 9.9 Any request for change of address and enclosing supporting documents later on will not be entertained.

#### 11. GENERAL CONDITIONS:

- 11.1 Candidate must be an **Indian Citizen**.
- Before filling up the application form candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. Their admission to all the stages of the recruitment process will be purely provisional subject to verification and satisfying the prescribed eligibility criteria as mentioned in this advertisement.
- Pre-requisites are minimum and mere possession of the same does not entitle the candidate to be called for Selection Process.
- 11.4 Call letters for calling candidates for selection process will be forwarded through e-mail only on the email ID mentioned in the application form.
- The short listed candidates will have to appear for the selection process at their own cost. Travelling expense will not be reimbursed.

- 11.11 The recruitment in MSETCL is done strictly as per merit. Canvassing in any form will disqualify a candidate.
- 11.12 This advertisement is published subject to the provisions of Maharashtra Civil Services (declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.

# 11.13 The candidates shall produce following certificate showing knowledge of Marathi:

- 11.15 Employees working in Government / Semi. Government Undertaking will have to produce No Objection Certificate at the time of interview if shortlisted for Personal Interview. The Departmental candidates are not required to submit the same.
