- 3) The candidates considered for selection shall be called personally for verification of their Documents/Certificates and eligibility criteria at the Corporate Office, Mumbai for which separate notification shall be given on Company's website and will also be intimated through e-mail on their e-mail address given in their application form.
- 4) Before coming for document verification, the candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. The selection of the candidate is purely on provisional basis subject to conforming the pre-requisites and other conditions notified in the advertisement.
