Terms and Conditions

- 1) The promotion of above Assistant Engineer (Trans) as Deputy Executive Engineer (Trans) is on **provisional basis without prejudice to claims and seniority of others if any.**
- 2) **Their promotions are subject to outcome/decision in the Writ Petition No.8452/04 filed by Shri. Vijay Ghogare & Others v/s the State of Maharashtra and others in the High Court of judicature at Bombay .**
- 3) Their promotion as Dy.Executive Engineer (Trans) shall be effective from the date of their joining as Dy.Executive Engineer (Trans) in pursuance of this order.
- 4) The above promotees shall draw pay in the pay scale of Rs.21365-845-25590-900-48090 in accordance with the provisions of S.R.29(a) read with 32(b). However, in respect of such of the promotees who have already been granted the higher grade benefit of the post of Dy.E.E./ E.E. under the provisions of G.O.111 (P) dt. 13.05.1982, their pay shall not be re-fixed again in the promoted post.
- 5) The detailed posting orders will be issued by concerned Chief Engineer.
- 6) The above promotees are held eligible for Tr.TA, Pay advance, Joining time etc., as admissible under Company Regulations wherever there is change in Head Quarter.

- 7) In case they refuse promotion to the post of Dy.Executive Engineer (Trans), the benefit of next higher grade of the post of Dy.E.E./ EE if granted to them on 1st and 2nd occasion shall be withdrawn from the date of promotion order in terms of the provisions under G.O.111 (P) dt. 13.05.1982.
 - 8) The promotees should communicate their acceptance or refusal of promotion as the case may be within 3 days from the date of receipt of this order. The refusal of promotion will not make the promotees entitled to claim retention at the same place on the grounds of refusal of promotion and liable for transfer in the same capacity.
2. The above promotees should be relieved on or before **30.06.2011 A.N.** Their salary shall not be drawn at the present place of working after **30.06.2011.**
 3. Their relief/joining reports be sent to this office.
