**OFFICE ORDER NO. 304**


On the recommendations of the Competent Selection Committee and in pursuance of the approval accorded by the Competent Authority i.e. the Chairman and Managing Director in exercise of the power delegated to him under Schedules III, IV & V appended to the MSEB Employees' Service Regulations read with Circular No.MSTRNSCO/DOP/Circular/2 dated 6.6.2005, **Shri. Raut Namdeo Hari (02048361) (ST) Manager (F&A)** presently working at **Finance & Accounts Department, Corporate Office, Mumbai** is hereby **promoted** as **Senior Manager (F&A)** in the pay scale of **Rs.25380-975-30255-1105-54565** on officiating basis on the following terms and conditions and posted to work in **WM Section, Finance & Accounts Department, Corporate Office, Mumbai** against the vacant post of Senior Manager (F&A).

**2. Terms and Conditions**

- (i) **His promotion as Senior Manager (F&A) is on provisional basis without prejudice to claims and seniority of others if any.**
- (ii) **The promotion of Shri. Raut, Manager (F&A) is subject to outcome/decision in the Writ Petition No.8452/04 filed by Shri. Vijay Ghogare & Others v/s the State of Maharashtra and others in the High Court of judicature at Bombay.**
- (iii) **The promotion of Shri. Raut, Manager (F&A) is on provisional / ad-hoc basis pending finalization of the pre-requisites and method of filling in vacancies by the MSEB Holding Company.**
- (iv) He shall draw pay in the pay scale of **Rs.25380-975-30255-1105-54565**. His pay on promotion shall be fixed as per the provisions under Regulation 29(a) read with Regulation 32(b) of the MSEB Employees' Service Regulations. However, his pay shall not be re-fixed again in the promoted post in case he have already been granted the higher grade benefit of the post of SM(F&A) / AGM(F&A) / GM(F&A) under the provisions of G.O.74 (P) dated 30.04.1974.
- (v) The Promotion of Shri. Raut as Senior Manager (F&A) shall be effective from the date of his joining as Senior Manager (F&A) in pursuance of this order.
- (vi) On his promotion to the post of Senior Manager (F&A) the seniority of Shri. Raut, Manager (F&A) shall be fixed as per M.S.E.B. Employees' Seniority Regulations, 1961.
- (vii) Shri. Raut, Manager (F&A) is not held eligible for Tr.TA, Pay advance, Joining time etc., as there is no change in Head Quarter.

- (viii) He should communicate his acceptance or refusal of promotion as the case may be within 3 days from the date of receipt of this order. The refusal of promotion will not make him entitled to claim retention at the same place on the grounds of refusal of promotion and liable for transfer in the same capacity.
- (ix) In case he refuses promotion to the post of Senior Manager (F&A), the benefit of next higher grade of the post of Senior Manager (F&A) / Asstt. General Manager (F&A)/ General Manager (F&A), if granted to him on 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> occasion shall be withdrawn from the date of promotion order in terms of the provisions under G.O.74(P) dated 30.04.1974.
- (x) No request for modification shall be entertained.
- (xi) In case, he is not relieved and not joined within 30 days from the date of this order, his seniority shall be reckoned from the date of joining in the promoted post.
3. He should be relieved on or before 16.12.2011 by making local arrangement failing which his salary shall not be drawn at present place of working.
4. His relief/joining report should be sent to the concerned establishment groups in Corporate Office, Mumbai.
