Annexure 'S'. TERMS & CONDITIONS

- 1. The period of the contract is Twelve Months from the date of the work order.
- 2. The incidental purchases items from schedule 'A' will be informed to agency as and when required.
- 3. The contract can be terminated in between; even, without giving notice; if the services are not satisfactory. In case of failure to carry out the work, then the work for remaining period will be allotted to the other agency at the contractor's risk & cost. An additional 15% supervision charges will be deducted from the pending bills &/or security deposit.
- 4. You are not allowed to transfer contract to any other party, in the event of violation of this clause, the contract will be liable for termination without any liabilities on the part of MSETCL.
- 5. The work should be carried out within the office working hours on working days only i.e. Monday to Saturday between 10 AM to 5.30 PM.
- 6. The computer system & its accessories should be cleaned using blower once in quarter.
- 7. If any hardware part required to be replaced, the MSETCL shall bear its cost separately.
- 8. Register for history & maintenance shall be maintained with assistance from an TL(IT)/ASA(IT) from the office.
- 9. The traveling charges will not be paid separately i.e. Traveling expenses will not be paid by the MSETCL to your representative/labours for attending the work as well as no other extra charges will be payable even for services provided after normal working hours specified.
- 10. Any disputes or differences arising under, out of or in Connection with the enquiry or contract if concluded, shall be subject to exclusive jurisdiction of Karad court.
