**2. Financial Criteria:-**

Average Annual financial turnover during the last 3 financial years ending 31<sup>st</sup> March of the previous financial year should be at least 40% of the estimated cost. In support of this the bidder shall submit the annual audited report certified by the statutory Auditor in case of Company & by the chartered Accountant where accounts are not required to be audited under any law

**3. Technical Experience Criteria:-**

- 3.1 The experience of Power sector bodies of State Government like MAHAGENCO, MSETCL, GETCO, APTRANSCO etc. / Central Government like PGCIL, NTPC is essential.
- 3.2 The Bidder must have experience of having successfully completed similar works {Similar works means Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation.} during last three years (from the scheduled date of submission of tender) having
- a) One similar completed works of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation costing not less than the amount equal to 50% of the estimated cost  
OR
- b) Two similar completed work of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation each costing not less than the amount equal to 40% of the estimated cost  
OR
- c) Three similar completed works of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation each costing not less than the amount equal to 30% of the estimated cost.

**Original Technical Qualifying condition mentioned above are amended as below & same is incorporated in Revised Tender Documents enclosed with RFX.**

**2. Financial Criteria:-**

Average Annual financial turnover during the last 3 financial years ending 31<sup>st</sup> March of the previous financial year should be at least 60% of the estimated cost. In support of this the bidder shall submit the annual audited report certified by the statutory Auditor in case of Company & by the chartered Accountant where accounts are not required to be audited under any law.

**3. Technical Experience Criteria:-**

- 3.1 The experience of Power sector bodies of State Government like MAHAGENCO, MSETCL, GETCO, APTRANSCO etc. / Central Government like PGCIL, NTPC, **etc** is essential.
- 3.2 The Bidder must have experience of having successfully completed similar works {Similar works means Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation.} during last three years (from the scheduled date of submission of tender) having
  - d) One similar completed works of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation costing not less than the amount equal to 80% of the estimated cost  
OR
  - e) Two similar completed work of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation each costing not less than the amount equal to 50% of the estimated cost  
OR
  - f) Three similar completed works of Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation each costing not less than the amount equal to 40% of the estimated cost.

**5. Consortium / JV Criteria:-**

- 5.1 The number of members in a consortium should not be more than two (including the lead member).
- 5.2 One of the members shall be authorized to be in charge (lead member), and this authorization shall be evidenced by submitting a power of attorney signed by legally authorized signatories of both members.
- 5.3 The bid, and in case of a successful bid, the form of Contract Agreement shall be signed so as to be legally binding on both members.
- 5.4 The member in charge (Lead member) shall be authorized to incur liabilities, receive payments and receive instructions for and on behalf to both members of the consortium and for the entire execution of contract.
- 5.5 Both members of the consortium shall be jointly and severally liable for execution for the contract in accordance with the Contract terms, and a relevant statement to this effect shall be included in the authorization mentioned under (5.2) above as well as in the Bid Form and the Form of Contract agreement (in case of a successful bid).

5.6 A **notarized** agreement should be submitted on non-judicial stamp paper of Rs.200/-. A copy of agreement entered into by consortium members shall be submitted with the bid. The consortium agreement should indicate precisely the responsibility of both members of consortium in respect of Transportation Contract for Loading /Unloading, Transportation of Material from various store to various Substations and from Substation to Substation etc. Both authorized signatory should be part of Board of Directors of each company. This should not be varied / modified subsequently without approval of the Employer.

5.7 Both members taken together shall jointly meet all the above qualifying criteria.

5.8 In case of JV, JV should be legally registered document.
