- 4) Security Deposit: The successful bidder will have will have to pay an amount equivalent to 5% of Contract value towards S.D. at EE 400kV, Deepnagar-Bhusawal-II..
- 5) Validity of Offer: The offer should be valid for our acceptance for a period of 60 days from the due date of same.
