4. **Name of the Work:** Work of loading/unloading, transportation of material from various stores to various substations & from various substation to substation under EHV O&M DN Baramati.

  - E) The Bidder must have experience for carrying out similar work experience. (The Experience Certificate not below the rank of Executive Engineer should be attached.)
