- 4. **Name of the Work**: Work of loading/unloading, transportation of material from various stores to various substations & from various substation to substation under EHV O&M DN Baramati.

  - C) VAT/TIN Registration.
  - D) PAN Registration.
  - E) The Bidder must have experience for carrying out similar work experience. (The Experience Certificate not below the rank of Executive Engineer should be attached.)
- 11. All general/technical/commercial terms and conditions of this contract of MSETCL are applicable to this contract.
- 12. Quantity: Quantities shown in Schedule "A" are tentative & subject to variation on either side.
