- 2) **Scope of work:** As detailed in Schedule 'A'.
- 3) **Quoted Rates:** The quoted rates should include the cost of material, all skilled and unskilled labour and also the requisite T&P, incidental charges etc. You are requested to quote your unit rates for the items mentioned in the schedule enclosed herewith. The rate should be inclusive of all taxes/ all applicable taxes and their charges should be mentioned separately & clearly.
- 4) **Completion Time:** The completion time for the work is 60 days from the date of handing over the site.
- 5) **Supervision of work:** The work shall be carried out under the Supervision of concern S/s In-charge.
- 6) **Penalty:** The work should be completed within stipulated time after handing over of site, if failed to do so penalty at the rate of 1% of delayed day will be charged subject to 10% maximum of (Order value).
- 7) **Guarantee:** The contractor will have to provide guarantee certificate for workmanship and material for one year from the date of completion of work.
- 8) **Payment:** 100% payments will be effected within reasonable time after satisfactory work completion from our EHV O&M Division Ratnagiri.
- 9) **Security Deposit:** The successful bidder will have to pay the security deposit within 7 days from the date of receipt of the order of amounting to 5% of order value to the office of Superintending Engineer EHV O&M Circle, Kolhapur in form of cash/ DD/Cheque/ FDR/ Bank Guarantee of any Nationalized/ scheduled Bank.
