Terms and Condition -

- 1 Mode / Destination of Work Filtration of oil of 80 MVAR,CSR at 400 KV R.S Karad S/s.
- 2 **Work Completion** The work is to be completed within 15 days from the date of handing over of site from concerned MSETCL's representative otherwise penalty at the rate of 1/2% per delayed week upto the 10% of the W.O.value will be levied.
- 3 **Offer -** Quotation in sealed envelope should be superscribed with the above referred enquiry number & Name of work.
- 4 Rate Rates should be firm & inclusive of all taxes, duties & cesses.
- 5 **Quantity -** The work is to be executed as per scope of work enclosed in Schedule 'A'. The quantity shown in Schedule 'A' is tentative & subject to variation on eitherside.
- 6 The details of the Shunt Reactor at 400 KV RS karad S/s for which work is to be carried out will be informed seperatly as and when required.
- 7 Transportation of filter machine will be on agency account and extra charges towards Transportation will not be paid.
- 8 The cable with adequate length & size for power supply will be provided by the contractor.
- 9 **Payment -** Payment will be released within **30** days against final M. B. Recording (SAP formalities). No advance payment will be released.
- 10 **Taxes** Rates quoted should be inclusive of all taxes, duties & cesses.
- 11 **Registration Nos.** -Please furnish your a) GST Registration No. b)PAN c) Insurance of Labour against workmen compensation Act etc.
- 12 **Experience-** certificate towards similar type of work done in the past 3 years.
- 13 **Validity** Quotation should be kept valid for 45 days from due date. Quotation received late with incomplete details against above clauses will not be considered.
- **Security Deposit:** The Security Deposit of 5% of the order value should be paid within 7 days from the date of intimation.
- 15 Testing of oil before and after filtration is to be carried out by the contractor with his own cost from the authorised agency/lab and report should be submitted to the In charge of EHVTL Project Subdivision Satara and Executive Engineer EHV PD Sangli. The works should be carried out to the entire satisfaction of In charge of EHVTL Subdivision Satara.
- 16 You are not allowed to transfer contract to any other party in the event of violation of above clause, the contract will be liable for termination without any liabilities on the part of MSETCL.
