In connection to the above subject this is to submit that, this office had invited above referred e-enquiries through SRM for supply of polythene sheets & grey cloth at various substations & Lines S/Dn. Kalwa under EHV (O&M) Dn., Kalwa. Last date of submission of bid was 27.07.2017. But till due date only one bid received against said enquiries.

Accordingly as per G.O.-I, F&A, Section-II, Works, Amended BR No. 81/17 dt.30.04.2013 Sr. No. 6 (Remarks – Sr. No.11) it is proposed to extend submission by 7 days i.e. from 12.07.2017 to 18.07.2017. But even after extension only 2 bids are received against said Enquiry.

In view of above as per G.O.–I, F&A, Section-II, Works, Amended BR No.81/17 dt.30.04.2013 Sr. No. 6 (Remarks – Sr. No.13) Executive Engineer is competent authority for giving second call (reenquiry) for aforesaid extension. In view of this, it is proposed to re-enquiry to this enquiry by 7 days i.e. from 16.08.2017 to 22.08.2017.

Further, it is proposed to extend date of opening of commercial & technical bids as given below :-
