Guidelines For Bidders to Submit Response After Amendment:

Name of work	Supply & commissioning of Bay unit (BCU) required for extension of Busbar protection for 1 x 50 MVA, 220/33KV Transformer commissioned at 220KV Wathar substation (MBR NO. 2714) under EHV O&M Division Kolhapur.

Following amendments have been made in above RFX (Tender). Prospecting bidder shall read these amendments carefully and submit/modify his bid according to these amendment and other conditions of tender document which are not related to these amendments:

- Bidders shall submit/re-submit their response as under:
 - Bidder shall enter basic price [including freight, packaging & forwarding, insurance, etc.] in ex-works field.
 - Bidder shall enter prevailing rate of GST in VAT % field as follows: -
 - In case SGST and CGST is applicable, the summation of these taxes [SGST + CGST] shall be entered in the VAT % field.
 - In case IGST is applicable, the same shall be entered in the VAT % field.
- Bidders who have submitted their response prior to issuance of this amendment have to invariably edit and re-submit their response against the amended RFX, failing which their offer is liable for rejection.

All other remaining conditions mentioned in the tender document shall remain same.
