

In constituting these general terms and conditions, annexure, specifications the following words shall have the meanings herein assigned to them.

- 1] The owner or purchaser shall mean the Maharashtra State Electricity Transmission Co. Ltd and shall include its legal representatives successor and permitted assigns.
- 2] RFx – RFx means the E-Tender floated by MSETCL in the SRM portal on <http://srmetender.mahatransco.in> website.
- 3] Vendor / E-Tenderer :-It means the registered agency enrolled on SRM e-Tenders ( New) portal of MSETCL and who is participating in the E-tendering process”.
- 4] Contractor :- The contractor shall mean the bidder whose bid has been accepted by the owner for the award of the contract and shall include such successful bidders legal representatives, successors and permitted assigns.



1] **Name of the work** :- Providing light motor vehicle. The operating authority and the head quarter of vehicle intended to be hired is as follows

2] **Condition & Type of Vehicle:**

The vehicle offered on rental basis shall be in its fittest condition; with comfortable seats; conforming to the latest standards of roadworthiness. Vehicle should carry Tourist permit.

3] **About the Bidder:**

The bidder must be either the owner of the vehicle, or should have a written agreement from the owner to rent out the vehicle to MSETCL.

4] **Validity of offer:**

The offer shall be kept open for our acceptance for a period of 90 days from the date of opening of the tender.


10] All corrections and alterations in the entries of tender papers shall be signed in full by the tenderer.

TERMS & CONDITIONS: (PART II)

1] **Rate:**

The rate offered should be on firm basis & will remain same throughout the period of contract and is inclusive of –

- a] Petrol/ Diesel, engine oil, grease and other consumables required for plying the vehicle on the road.
- b] All the taxes including wheel tax, comprehensive insurance, and any other statutory tax applicable. (However, the incidental charges such as parking charges, toll/ entry tax, etc. will be borne by the user.) i.e. MSETCL
- c] The services of the driver.
- d] 2500 km of run in a calendar month & the approved daily rate will be paid. Beyond that, per km charges will be applied.
- e] The run of the vehicle between 09.00 hrs. to 19.00 hrs with one hour recess in between for the driver. Normally the recess shall be between 13.00 to 14.00 hrs.
- f] Maximum Rs. 40000/- per month is the limit including all charges.

2] **Operative Period:**

Operative period of the contract will be started from date of actually engaging the vehicle up to 31 March 2018.

- 3) **Duty period** : The vehicle will be utilized on any days and it must be made available within a short notice from the concerned office / officer. The charges will be paid for the days when vehicle is actually utilized. The charges shall not be paid for the days when vehicle is not available. The concerned field officer in-charge of the vehicle under whom the vehicle is being utilized is empowered to give off on any day without assigning any reason, for which no charges will be paid for that day/days. Duty period of the vehicle will be 10.00 hours duty per day adjustable or fixed as per M.S.E.T.C.L.'s requirement.

4] **Security Deposit:**

A Security deposit at the rate of 5% of the order value should be paid on receipt of the order within seven days. The security deposit may be paid in the form of BG from a nationalized / scheduled bank, or by cash, or by DD in the Office of the Superintending Engineer, EHV O&M Circle, Takka Colony, Panvel.

- 5] **Completion of Statutory Formalities:** All formalities in respect of RTO shall be completed by you regarding registration of vehicle, payment of taxes, permission for hiring of vehicles (T permit), road permit etc. Comprehensive insurance of the vehicle valid for the entire period of contract is mandatory, and should be done with Insurance Authorities. Necessary 'PUC' certificate shall be obtained in the intervals as prescribed in statute.

6] **Maintenance of Vehicle: -**

A timely maintenance of the vehicle should be carried out including servicing of the vehicle so that the vehicle hired to us shall always be in a perfect condition to ply on the road. In case the user/officer finds that the vehicle cannot be utilized for certain defects, lack of fuel, or any incomplete statutory formality, the officer shall refuse to take vehicle on duty on that day. Such absence of duty shall entail severing of the contract and penalty will be applied equal to daily rate (additional).

7] **Penalty for Default:**

You shall provide the alternate vehicle (with due approval of the undersigned) in case of non-availability of regular vehicle due to break down. If you do not provide the vehicle, the penalty at the rate of 100% the approved daily rental will be deducted from your bills. However, this penalty may be revoked in case of genuine reasons beyond the reach of the contractor, and in case of advance intimation of his inability to provide the vehicle. The condition shall be got certified from the officer controlling the vehicle or from Executive Engineer. After normal duty hours, in case of emergencies, if vehicle is not made available to Office, a penalty of Rs. 5000/- will be applied & deducted from your bill.

8] **Driver:**

The driver engaged should have a valid license with 3-5 years experience. The driver should be polite in behaviour. He should be on duty with neat and clean clothes; should be obedient and free from any kind of bad habits. In case anything wrong is found with the driver, the vehicle shall be immediately discontinued. The driver should know Marathi/Hindi. He should be able to write all the entries of vehicle travel in a diary. He should have his own mobile phone in operating condition.

9] **Liability:**

In case of any accident while the vehicle is on duty with us, on account of the vehicle not being in good condition, or on account of bad/ rash driving, or on any other account, the consequences shall be to your account. The liability of any court awarding any kind of damages to the person met with accident or his/ her heir, shall be solely yours.

10] **Loss and damage :**

The M.S.E.T.C.L. will not be responsible for any damage / loss to vehicle or the driver or any outside party during the validity of contact period. Any loss /damage to the M.S.E.T.C.L.'s property and injuries to staff or person, Occurring due to the vehicle shall be made good at the cost of contractor for the cost as decided by the M.S.E.T.C.L./Authority and same should be remitted immediately in the office of the Executive Engineer, E.H.V. Testing Division, M.S.E.T.C.L.,Panvel or SE, EHV O&M Circle, Panvel. Insurance as per motor vehicle act should done properly.

11] **Maintaining vehicle diary:**

The driver of the vehicle shall maintain the vehicle diary indicating time of arrival, time of leaving the duty period. He shall also indicate the km. usage from place to place. The diary should be submitted along with the bill for payment.

In case the owner, for purposes other than this contract, uses the vehicle, shall make specific km. entries.

12] **The transport contracts should abide by all relevant laws of the land:**

Our Engineer-In-charge will initially verify of the following documents-

1. Comprehensive insurance of the vehicle.
2. Registration certificate / R.C. Book.
3. Tourist and or taxi permit bearing 'T' mark wherever required.
4. Public carrier permit from statutory authorities.
5. Pollution under control certificate.

These documents shall always be available with the vehicle.

13] **Payment:**

14] **Tax Deduction At Source:**

Income Tax as per the prevailing rate will be deducted from the bills. Similarly, any other taxes deductible at source, if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government) will also be deducted from the bills at the prevailing rates.

15] **Termination Of Contract:**

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect.


16] **Applicability Of General Conditions Of Contract:**


