I. Submission of bids:

Two bid system should be followed for submitting the offer. Uploading of required document shall be done on MSETCL’s SRM E-Tender website.

All eligible supplier/ contractors are mandated to get enrolled on SRM E tender (new) portal of MSETCL.

The RFx complete in all respect should be submitted between the period from 25.05.2017 19:00 Hrs to 08.06.2017, 23:59 Hrs. positively.

- A. **Techno-commercial bid:** This should contain following documents, certificates (all self attested copies) as a proof of qualifying pre-requisites, brochures, attested certificates etc.

1. Valid shop act & establishment registration/grampanchayat NOC as applicable.
2. VAT registration certificate.
3. Service Tax registration certificate along with <u>challan</u>
4. PF, EPF,ESIC registration certificate with challan if applicable . If not applicable give undertaking for that.
5. Authorization for Service Centre of CASSET type BLUE STAR AC . Attach require documents regarding this.

Please Note that all above mention documents are compulsory
Failing to submission of above said documents will lead to reject the offer.
The copies enclosed must be easily readable.

If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office. Payment will be effected for valid period only.

- B. **Price bid:** Bidder should upload the digitally signed price bid under commercial bid online.

a] Techno - commercial bid will be opened online for all received bids. After verifying the set of documents / certificates submitted in Techno - commercial bid for prequalification as mentioned above, if it is found that, the bidder fulfills the desired prerequisites; the price bid will be opened online.

If the same is not found to be meeting the prerequisites, the Price bid shall not be opened.

b] This office reserves all the rights to reject any or all bids without assigning any reasons thereof.

c] The offer shall be valid up to 120 days from the date of opening of the quotation/bid.

II) Other Terms & conditions :-

- 1) **Scope of Work-:** As detailed in schedule-“A” attached.
- 2) **Quoted Rates-:** The rates quoted by your firm should be including of all taxes, incidental charges, & requisite T&P **excluding service tax and VAT (detail mention in schedule-“A” attached) as per applicable rate & relevant act.**,all other local taxes will be borne by agency at their own cost.
- 3) **Completion Period-:** The work should be completed in a 90 days_ as per directives the Executive Engineer, EHV O&M Division, Dhule or his representative.
- 4) **Payment-:** On completion of job successfully, the bill in triplicate should be submitted to concerned Sub-station incharge separately. After recording of measurements by concerned Sub-station in charge, the bill will be certified by Executive Engineer for effecting the payment . Payment will be effected as per availability of funds.
- 5) **Security Deposit-:** The successful bidder will have to pay an amount equivalent to 5% of contract value towards SD at Division Office, Dhule.

- 6) **Validity of order-**: The validity of work order will be six months from the date of issue of work order,. In no case the program laid down should be delayed
- 7) The material supplied & work carried out by you should be guaranteed for 12 months from the date of work completion. **The guarantee certificate should be submitted along with the bill.** If any defect occurs within the guarantee period you should have to re-carry out the work / replacement / repair free of cost.
- 8) During the execution of work if it is found that, the quality of material & workmanship is not as per our satisfaction, the undersigned reserves the right to terminate the contract immediately & recover the penalty as would be deemed.
- 9) The material should be of good quality & as per standards of **Original BLUE STAR AC** specifications. The material to be used in execution of the works must be got approved from the Executive Engineer or his designated representative in advance, and only approved materials should be used.
- 10) The income tax on the bill submitted, will be deducted as per Govt. Norms from the bill & certificate of the same will be sent on demand. Please mention the PAN, VAT & service tax number on your quotation & bill. Similarly any other tax deductible at source, if applicable to this particular contract, as per statutory provisions laid down by Central or State Govt. will also be deducted from the bills at the prevailing rates.
- 11) The insurance of your labours will have to be done at your cost. If failed to do so any compensation or claim arise will be your responsibility.
- 12) The time stipulated in the contract for the completion of the work shall be deemed to be the Essence of contract. The contractor shall so organize his resources & perform his work as to complete the work within stipulated time period.
- 13) Acceptance of the work order / LOI shall be treated as acceptance of these conditions of the Enquiry by the contractor.

Contractor will have to take all the precautions at his own cost until handing over the site back to MSETCL. **If any accident occurs to the labour skilled or unskilled, compensation if any, is to be paid by the contractor at his own cost.**
- 18) Contractor will be responsible for the quality of work & workmanship. The material used to be strictly as per specifications & standard.

19) The successful Contractor should submit the agreement bond on stamp paper as per MSETCL norms before submission of the bills.
