17. The normal working time for the crane, on the required day, will be from 07:00 Hrs to 19:00 Hrs. However in case of emergencies, the crane have to spared by the contractor before or after the stipulated time as per the instructions of Executive Engineer, 400kV RS Dn, Khadka-Bhusawal.

18. The contractor will be intimated 12 Hrs. in advance whenever the crane is required. However in case of emergencies, no prior notice can be given, and the contractor have to arrange the crane immediately whenever told by the Executive Engineer, 400kV RS Dn, Khadka-Bhusawal.

19. The crane provided by the contractor should be provided with all necessary crane belts, its binding

20. The crane fuel (diesel/petrol) and lubricants to be borne by the crane provider. This office will not 21. If in case, the crane fails or stops working in the middle of the work, the contractor has to immediately

provide another crane suitable for the work.

22. The necessary maintenance to be carried out and the cost of the same to be borne by the contractor only.

23. Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd's property due To your employees' negligence during the course of contract shall be on contractor's part and same shall
