Sub: - E-enquiry for providing of 1 No. TATA Sumo or any equivalent LMV taxi Permit Vehicle along with Driver on hired basis for Addl.EE, telecom lab sub division Nanded under Testing Division Nanded as per the scope of work as per Schedule "A".

Sealed super-scribed quotations duly quoted are invited for the work of providing of 1 No. TATA Sumo or any equivalent Taxi Permit LMV along with Driver on hired basis for Addl.EE, telecom lab sub division Nanded under Testing Division Nanded as per the scope of work as per schedule "A" on or before Dt:16.09.2017 UP TO 17:30 Hrs. on letter head along with supporting documents. Quotation will be opened on 18.09.2017 if possible.

The rate should be offered in Schedule "B" attached herewith.

The Quotation shall be accompanied with the following documents as mentioned below:

- A. Attested copy of valid Registration of the vehicle issued by R.T.O.
- B. Attested Copy of registration under Bombay Motor Vehicles (BMV) Tax Act, 1958 and fitness Certificate of vehicle under Motor vehicle act 1988.
- C. Attested copy of Recent Pollution Test Certificate (PUC).
- D. Attested copy of Motor vehicle Insurance duly renewed.
- E. Attested copy of Taxi Permit certificate. The vehicle on hiring should have Valid "T" permit issued by concerned authorities.
- F. Driver should possess the valid Transportation License's authorized by RTO. Attested copy of valid driving license of the driver shall be submitted after award of contract.
- G. Attested copy of PAN Card of authorized Signatory.
- H. Attested copy of Service Tax Registration if applicable.
- I. An agreement on non-judicial stamp paper of Rs.100 in between agency and vehicle owner shall have to be submitted if the order is awarded to the agency, in case if agency is not a vehicle owner.

The Terms and conditions are as follows:-

1. **Period of Work:** - From 01.10.2017 to 30.09.2018 or Exhaust of value of Rs. 200000/- whichever is earlier.
2. **Value of Work:** -Value of work is limited to Rs. 2, 00,000/- (In words: - Rs. Two lakhs only) inclusive of taxes.
3. The fuel consumption for the vehicle will be considered @ 12 Kilometer/Ltr. The same shall be reimbursed to the agency as per prevailing market rates for actual running of vehicle for MSETCL use.
4. Preference will be given for the latest manufactured vehicle (i.e. passing of vehicle after January-2013) and considering overall condition of the vehicle by inspecting the vehicle.
5. The quotations should be properly, sealed and super scribed with the Envelopes "**Quotation for providing of TATA Sumo or any equivalent Taxi Permit Vehicle along with Driver on hire basis for Addl.EE, telecom lab sub division Nanded under Testing Division Nanded**".
6. If work is allotted, the agency shall have to pay Rs. 10,000/- (Rs. Ten Thousand only) without any interest, as Security deposit i.e. 5% of order value, within 7 days from the date of allotment of work in terms of cash,DD to the office of the Executive Engineer, EHV Testing Div. Nanded. If you fail to execute the work in full or part security deposit will be forfeited.
7. An agreement has to be signed with MSETCL regarding abiding with all the terms and conditions of the work on a non-Judicial stamp paper of Rs. 100/- if work is allotted to you.
8. An alternate taxi permit vehicle shall immediately be provided in case of any breakdown to the vehicle or any other reason , otherwise per day rent or actual expenses incurred on hiring of similar vehicle from any other party, whichever is higher will be recovered from the RA bill/security deposit.
9. There will be weekly off for which no payment will be made however if the vehicle is used in emergency for that the payment will be made at the rate agreed at the time of work allotted.
10. Driver employed for the hired vehicle should possess valid driving license issued by the Competent Authority of the government & should be sufficiently experienced to drive on the road including state & National Highway. The Driver should know reading either Marathi / Hindi.
11. The agency engaged for the work will be responsible for compliance of all the statutory obligation under the labour act, minimum wages act. Contribution under employee P.F. profession tax etc. in respect of skilled worker- cum- vehicle driver.
