Sealed & Superscribed **Quotations** are invited so as to reach this office on or before **25.09.2017** for Hiring of Vehicle (Diesel) preferably SUMO/BOLERO on per day basis for EHV Lines Projects Sub Division, MSETCL, Malegaon as per enclosed **Schedule 'A'** with following terms & conditions.

Terms & Conditions:

- 1) While quoting the rates, the taxes if any, should be mentioned clearly.
- 2) Income tax at source as per rules will be deducted from bill as per the prevailing rates.
- 3) Only fuel will be supplied by the MSETCL.
- 4) The MSETCL will not be responsible for any kind of accident or damage during the hired period. All the financial liabilities arising out of accident shall be borne by the owner of vehicle.
- 5) Vehicle registration should not be before 05 years.
- 6) Vehicle must be running on diesel and preferably SUMO/BOLERO and registered with Tourist Permit.
- 7) The mileage per liter of the vehicle should not be less than 15.0 kms/ltr.
- 8) 5% Security Deposit is to be deposited in Cash/Crossed DD/Cheque before engaging the vehicle.

- 9) As per provision of 'Mumbai Mudrank Adhiniyam, 1958 clause No.34' an agreement on appropriate value of stamp paper shall have to be executed with MSETCL for execution of contract satisfactorily before engaging the vehicle. The amount of the fees for such an agreement shall be borne by contractor.
- 10) The working hours will be normally from 09:00 to 18:00 hrs. on working days. However, in case of emergency, it will be required beyond 18:00 hrs or before 9:00 hrs & on holiday also, with no extra charges.
- 11) Any kind of vehicle breakdown should be attended by owner. No charges will be paid by MSETCL.
- 12) Driver should be managed by vehicle owner. He should have valid license to drive such type of vehicle.
- 13) All the provisions under rules and laws regarding registration, annual passing fees, and taxes of vehicle should be borne by vehicle owner.
- 14) If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation after giving 24 hrs. notice.
- 15) All other standard terms and conditions of the contract prevailing in MSETCL are applicable in this case.
- 16) In case of failure of vehicle due to any reason, the vehicle owner has to provide another same type of vehicle on same rate and terms & condition without any delay.
- 17) You will have to submit copy of documents such as valid registration certificate, Insurance policy certificate, Fitness certificate, tourist permit, Road Tax certificate, driving license, etc. as per Motor Vehicle Act along with the quotations and produce the original copies for verification whenever demanded by MSETCL authorities.
- 18) With 07 days prior notice, the contract will be terminated, if departmental vehicle is made available by MSETCL for this office.
- 19) Prior notice of 01 month will be required if contractor want to terminate the Contract during contractual period.
- 20) The undersigned reserves the rights for cancellation of any or all quotations without assigning any reason.
- 21) In case of any dispute for this contract, the jurisdiction of court will be Nasik.
