1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date:- 10.09.2017**
2. Document should upload the following digitally signed scan copies of documents/certificates online under **Technical Bid**.

**•Submit the performance /Experience certificate / Work order copies for servicing, trials and attending troubles (if any) of various isolators with or without Earth Switches for 400 kV and above rating from any Indian Electricity transmission utility.**

**Experience of servicing, trials and attending troubles (if any) of various isolators with or without Earth Switches for 400 kV and above rating.**

The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate.

- PAN Card & GST Registration.
- P.F. Registration.
- Income Tax return for last three years
- Valid Electrical Contractor License and Shop Act License.
- Valid Workman Compensation Policy. Valid insurance policy from M/s. United India Insurance Co. Ltd., on co insurance cum servicing basis in the ratio of 40:60 (i.e. the Govt. Insurance fund @40% and the United India Insurance Co. Ltd., @60% which will be valid for 2 years from the date 01.12.2013) entrusted by Director of Insurance , Govt. of Maharashtra. **The INSURANCE will be required at the time of execution Before issue the purchase order.**
- List of skilled personnels along with qualifications.
- List of T&Ps available with the agency for execution of work.

- Annual Turnover for last 3 years duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- 3) Rfx fee is Rs.106/- including taxes (Is non refundable)
- 4) If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 5) Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company for the satisfactory completion of the contract in the approved Performa of agreement of the Company. until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, under the contract. The cost of necessary stamp paper for the agreement shall be borne by the contractor.
- 6) Rates should be inclusive of all taxes & Service Tax should be Mentioned Separately.
- 7) You have to pay amount equal to 5% of the purchase order value within 15 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, in cash, or Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt. The payment of Security Deposit in any other alternative form is not permitted. No interest will be payable by the MSETCL to the Contractor on the Security Deposit. Security Deposit will be refunded after due completion of contractual obligation.
- 8) Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 9) Contractor will be responsible for any type of accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing "Workman's Compensation Act"
- 10) Income tax, Insurance, Labour cess, GST & WCT as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which necessary certificate will be issued from this office.
- 11) Rates should be valid for 90 days.
- 12) Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- 13) Agency should be rate quoted at Estimate cost on Percentage (%) basis.
- 14) The undersigned reserves the right to reject any or all the quotations without assigning any reasons thereof. Bidders to submit/re-submit their response as under:
  - Enter basic price [including freight, packaging & forwarding, insurance etc.] in ex-works field.
  - Enter prevailing rate of GST in VAT% field as follows:-
    - In case SGST AND CGST is applicable, the summation of these taxes [SGST + CGST] to be entered in the vat% field.
    - In case IGST is applicable, the same to be entered in the vat% field.
    - Estimated rates for RFX are calculated considering 15 % Service Tax (as per old Tax criteria), accordingly bidder have to submit their response by calculating the ex-works price & applicable rates of GST .

Taxation terms & conditions in the booklet are revised as per GST regime.
