### TERMS AND CONDITIONS

- **1. Due Date: -** The Due date of submission of Techno-commercial & Price Bid in SRM system is on or before Dt. 27.09.2017 up to 23:59 Hrs Positively.
- **2. Scope of work** :- As detailed in schedule' A'
- **3. Quoted Rates**: The quoted rates should including the cost of material, all skilled and unskilled labour charges and also the requisite T & P, incidental charges etc. The Taxes & charges shall be mentioned clearly. If not mentioned then it will be considered as inclusive of all taxes & charges otherwise Tax will be paid as per Prevailing rates.
- **4. Completion Period:** The work completion period is for One Year from date of receipt of work order and handing over the site. However work should be completed as per the schedule given by concerned Addl. Executive Engineer or as per directed by site in charge.
- **5. Payment: -** On completion of job successfully, the Quarterly RA bill in triplicate should be submitted to The office of Addl.Ex.Engr. Sub-Station Maintenance, Sub-division 400kV RS Khadka

for bill payment .The Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in M.B.by Addl. E.E S/stn Maint Sub-Division 400KV R S Khadka.

### **6. SECURITY DEPOSIT:**

- a. The successful Contractor(s) will have to submit **Security Deposit** at the rate of 5 % of the value of the order, by cash /Demand Draft / Fixed Deposit / Bank Guarantee at the office of the Executive Engineer, 400kv Rs Dn. Khadka, Bhusawal within 07 (Seven) days from the date of receipt of letter of intimation. The detail order will be issued only after the payment of security deposit.
- b. The Demand Draft / Fixed Deposit / Bank Guarantee submitted towards the Security Deposit shall be in the name of the Executive Engineer, 400kv Rs Dn. Khadka, Bhusawal.
- c. The Bank Guarantee shall be on a Scheduled Bank / Nationalized Bank and it shall be valid until 90 days after the contract period and the claim period shall be for further 90 days.
- d. If the successful Contractor fails to submit Security Deposit within the stipulated period, it will be presumed that the Contractor is not interested in execution of the contract and the work contract will be issued to other agency (i.e.). The decision of E-enquiry accepting authority i.e. the Executive Engineer, 400kv Rs Dn. Khadka, Bhusawal shall be final and remain binding on the Contractor(s).
- e. No interest will be paid on the Security Deposit and the Security Deposit will be refunded after satisfactory execution of works / guarantee period, whichever is later.
- 7. The Security Deposit will be returned to the Contractor without any interest after 90 days of successful completion of the Contract Period and after completion of Contractor's other obligations under the Contract.
- **8.** Validity of Offer: The offer should be valid for our acceptance for a period of 180 days from the due date of same.

### 9. Documents required to be attached along with offer:-

Following are the list of qualifying documents required please attached for qualifying in the Techno-Commercial Bids for opening of the price Bids.

- a. Valid Electrical Contractor License.
- b. Valid GST registration certificate.
- c. Copy of PAN card.
- d. Valid Firm Establishment copy or Shop Act Registration or Gram Panchayat NOC.
- e. Work order along with work Experience certificate issued by authority not below the Rank of Executive Engineer of similar type works as a proof of experience.

# If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

The above qualifying requirement is available in the question format in the RFx. The bidder has to answer all the questions at the time of bidding and also the supporting documents are required above shall be uploaded by the bidder. The documents will require digital signature at the time of uploading to the SRM Portal, the bidder has to connect the digital signature key at the time of uploading the qualifying documents/any attachment.

- **10. Rates & Taxes: -** The Rates quoted should be valid at least for 6 months and should be including of all taxes, Labour charges & incidental charges as per applicable rate & relevant act. Please quote your GST registration No. on quotation.
- 11. T&P: All the T&P, required for above work will be arranged by the Contractor.
- **12. Safety: -** The contractor shall ensure the safety of all the workmen, materials and equipment either belonging to him or to other working at site. The contractor shall be responsible for providing of all safety notices and safety equipment required. If any accident occurs during the work, the complete

responsibility of the accident will be of Contractors. The M.S.E.T.Co.Ltd. shall not pay any type of compensation for any type of accident

- 13. Income tax & GST: Income tax & GST will be deducted as per rules from Bill.
- 14. Accommodation: No living accommodation at site will be provided by M.S.E.T.C.L.

#### 15. AGREEMENT & STAMP DUTY:-

- a. The successful Contractor has to execute an Agreement with The Executive Engineer, 400kv Rs Dn. Khadka, and Bhusawal within 7 days after receipt of letter of intimation, the work order will be only issued after executing the Agreement & submission of security deposit @ 5 % to this office
- b. The successful Contractor shall submit an Agreement Bond on non-judicial stamp paper as per the Clause 63 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.
- **16. General:** MSETCL general Terms and Conditions for works are applicable to this contract. The undersigned reserves the rights to accept or reject any or all the Bidders without assigning any reason thereof.
- **17. LIABILITY OF ACCIDENT / LOSS:** The contractor will be responsible for any accident to any of his personnel or loss to him during the work. The responsibility of the insurance towards the same shall be with the contractor. The compensation to the contractor's personnel will be the responsibility of the contractor.

### 18. CONTRACTOR'S DEFAULT:

- a. In case you fail to complete work fully OR partially, the security deposit will be revoked by MSETCL. In this case the balance work will be got done from other agency may be at higher rates and the difference in cost will be recovered from the contractor's bills.
- b. In case of any loss / damage to the Owner's asset /material, it will be the sole responsibility of the contractor to lodge the complaint in writing to the nearest police station under intimation to this office or to In-charge/ designated officer.
- **c.** If there happens any loss of goods or damage to valuable material in the premises on account of negligence of the Staff, the cost of loss / damage shall be recovered from the contractor.
- **19. SUSPENSION / HOLDING OF WORK:** If the work has to be suspended due to any reason i.e. stay order from court of law, legal held up from any other Agency, shut down etc. the MSETCL shall not pay any compensation / damage to the contractor towards item like idle labour, etc. In such cases the contractor is not liable for claiming extra payment.
- **20. DEDUCTION:** Any Amount which become payable by the contractor to the MSETCL under particular contract will be deducted by the Owner from any amount due or becoming due to him to the contract under the same or any other contract.
- **21. SAVE AND EXCEPT:** Amount due to account of damage or compensation for default or breach of contract by the contractor in which case instead of deduction of the same amount shall be retained and the Owner shall have the right on amount so retained or withheld.
- **22.TERMINATION OF CONTRACT:** The Undersigned reserve the right to terminate the contract at any stage without assigning any reasons thereof.
