EXPRESSION OF INTEREST

Accommodation is required to Maharashtra State Electricity Transmission Co. Ltd. on monthly rental basis to meet following requirement for the office of Chief Engineer (PAC), Internal Audit and Training Sections of Corporate Office, MSETCL, Prakashganga, Bandra, Mumbai.

Requirements:-

- 1) Carpet Area of the premises should be around 6000 Sqft.
- 2) It should be preferably located at Airoli, Mahape, CBD – Belapur of Navi Mumbai City and Bandra – Kurla Complex, Chembur of Mumbai City.
- 3) Accommodation should be suitable for providing cabins for officers and work stations for staff.
- 4) There should be reserved parking slot for 10 Vehicles of Four & Two wheeler each.
- 5) The space should be preferably centrally air conditioned. If not the same should have good natural ventilation.
- 6) There should be separate electric meter and minimum supply of 20 KW load is expected on the system.
