- 4) **Name of the Work**: Work of replacement of damaged & deterioted earth wire of various EHV lines under EHV O&M Division, Baramati.
- 5) **Taxes and Duties**: The rates should be quoted be excluding taxes, levies, incidental charges, Octroi, packing, forwarding, transportation, statutory charges, etc. if any fright, insurance.
- 6) **Rate Validity**: The rates offer submitted by you should be valid at least 180 days from the last date of quotation.
- 7) **Security Deposit**: You will have to pay S.D. at rate 5% of the total amount or order within 7 days from the receipt of firm order, if asked for.
- 8) **Payment**: 100% payment will be made after the work completion by EHV O&M Division Baramati as per availability of funds.

- 9) **Delivery Periods**: You are requested to carry out Work of replacement of damaged & deterioted earth wire of various EHV lines under EHV O&M Division, Baramati as stated in schedule 'A' on or before 31.03.2018.
- 10) Along with quotation following documents should be attached:
  - A) Valid Electrical Contractor's License.
  - B) Valid Registration under GST.
  - C) Valid Shop Act License/ NOC from Local body.
  - D) The Bidder must have similar work experience.
- 11) List of similar works executed by the contractor elsewhere preferably with testimony from the concerned shall be attached with this document.
- 12) All general/technical/commercial terms and conditions of this contract of MSETCL are applicable to this contract.
- 13) Quantity: Quantities shown in Schedule "A" are tentative & subject to variation on either side.
- 14) The T&P labour, machinery, equipment /material required for the said supply of material shall be to your account.
- 15) **Penalty:** If you fail to supply the material in stipulated time as mentioned above, you will be liable to pay penalty at rate of 1% per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.
- 16) **Guarantee**: The material to be supplied should be of the best & of standard quality & as per specification shown in schedule 'A'. The defective material should be replaced at your risk & cost. The guarantee of material will be 12Months from the date of supply.
- 17) You should be fully aware of the M.S.E. Trans. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- 18) **Income tax**: if applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.
- 19) The quotation not confirming to the specification is likely to be rejected.
- 20) The right to modify/ alter /cancel the quotation is reserved by the undersigned.
