Terms & Conditions:


- 1) **RATES:** The rates shall be inclusive of all taxes as per prevailing GST regime. The rates quoted shall be valid till complete supply and the rates quoted shall be firm for at-least four months whichever is later. The bidder should have to quote the ex - price and taxes separately if any. The bidder should have to submit the HSN code of the material.
- 2) The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR SUPPLY OF (Enquiry no. ____ be quoted)
- 3) Your quotation should reach this office on or before 16.10.2017 upto 17.30 Hrs and the same will be 'opened' on the same day, if possible.
- 4) No T&P and Labour will be provided by the company.
- 5) The material shall be supplied within 30 days at EHV Projects Circle, Pune from the date of receipt of this office order otherwise penalty @ 1% per week subject to max 10% of the order amount will be levied at the discretion of the Competent Authority.
- 6) Income tax will be recovered as per prevailing rules.
- 7) Payment will be effected by this office by Account Payee cheque after satisfactory supply of material.
- 8) The undersigned reserves right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.
- 9) Please quote your PAN & GST No. in the quotation.
- 10) The applicant / Bidder must have valid GST and PAN issued by the Income Tax Department and submit registration certificate.
- 11) The manufacturer should submit valid NSIC/ SSI certificate and ISO 9001:2015 certification for the quality management system if any.

- 12) Three sample of rain suit must be submitted with manufacture's label as per specification
- 13) Authorization original letter from manufacturers of Rainsuit as per Annexure "A" & specifically mentioned Bid number
- 14) The copy of latest Shop Act License must be submitted.
- 15) Updated solvency certificate of Nationalized / scheduled for amount of minimum Rs. 60,000.
- 16) **Experience:** The applicant should have an experience of successfully completed supply of Rainsuit worth Rs. 2 Lakhs during the last 5 years from the tender/ enquiry closing date. Purchase order received from Central Government, Municipal Corporations or State Governments or any organizations under Central / State Government only will be considered for this purpose. Single purchase order of Rs. 30,000 will be considered for evaluating this tender / enquiry requirement.
- 17) Security Deposit of 10% is applicable and will be refunded only after finalization of order.
- 18) **Agreement:** - The Contractor will have to enter into an AGREEMENT with the Company to carry out the contract in the prescribed form on non-judicial court stamp paper of appropriate value as per MSETCL's Adm. Circular No.207 Dt.17.04.2010, within 07 days from the receipt of detail / clear order. The cost of the stamp paper will be borne by the Contractor. If the agreement is not submitted the payment will be withheld.
- 19) Please note that, all the mentioned documents submission is must. Any other alternate document will not be considered.
- 20) Proof of having average annual Turnover during the last 3 years. The minimum average turnover during last 3 years shall be 60% of the estimates cost and certified by the Chartered Accountant on the basis of audited financial statements.
- 21) List of similar supply executed during last 3 years.
- 22) Make (brand name) & detail guaranteed features of specification along with illustrated printed catalogue should be submitted.
- 23) Income Tax return for the year 2016-17.
- 24) The Quantity of the sizes may vary. However, the total no. of requirement will remain the same.
- 25) **Replacement:** - If material is found defective due to any manufacturing defect on the part of manufacturer, the same will have to be attended / replaced, free of cost during guarantee period for trouble free operation.
- 26) MSETCL reserves right to add more terms / conditions modify / amend them during the contract period if found necessary in the interest of MSETCL.
- 27) **Rejected Quantity:**-No argument will be accepted for rejected material, decision of the undersigned will be final & rejected quantity, if any must be supplied in one single lot with 15 days from the date of receipt of intimation report.

- 28) **Warranty:-**One year towards any manufacturing defect
- 29) **Delivery period:-** 30 Days from the date of receipt of order
- 30) If during inspection / sample checking the material quoted is not found upto the Mark in terms of quality by the purchase committee, the whole process will be cancelled /terminated at any stage in the interest of MSETCL. The U/s reserves the rights to cancel / terminate the tender process at any stage without giving any reasons. In such cases the e-enquiry will be refloated.
- 31) Bidder should carefully read all the TERMS AND CONDITIONS/ INSTRUCTION & follow the same scrupulously. In case of any omission, the enquiry shall be liable for rejection.
- 32) In case of any doubt in respect of any schedule or clause, it should be got clarified in writing from the office of the undersigned before submitting the e-enquiry well in advance. Any complaints in this regard will not be entertained after opening of e-enquiry.
- 33) **Agreement:** - The Contractor will have to enter into an AGREEMENT with the Company to carry out the contract in the prescribed form on non-judicial court stamp paper of appropriate value as per MSETCL's Adm. Circular No.207 Dt.17.04.2010, within 07 days from the receipt of detail / clear order. The cost of the stamp paper will be borne by the Contractor. If the agreement is not submitted the payment will be withheld.
- 34) PENALTY FOR LATE EXECUTION**
In the event of supply not completed within the period stipulated in the contract, the contractor shall be liable to pay the charges at half percent per day of delayed supply subject to maximum of 10% of the order value Due consideration may be given in levying such charges for reasons absolutely beyond the control of the contractor on submission of necessary documentary evidence/satisfactory reasons.
- 35) **JURISDICTION:** All the disputes arising out of this contract shall have exclusive jurisdiction of court in Pune.
- 36) **Qualifying conditions:**
- A) Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 60% of the estimated cost.
- B) The bidder shall be manufacturer or should have to submit the Valid Authorization letter from the Manufacturer for this tender.
- C) The Tenderers are requested to submit the certificate of previous experience in supply of rain suits, gumboots with detailed information. The produced experience certificate should not be below the rank of E.E. or equivalent

- D] The technical specifications for the products as specified under this tender documents.
- E] Proof of GSTIN Registration.
- F] Income tax returns of last 3 years (2011-12, 2012-13 and 2013-14) with PAN card copy and audited balance sheets.
- I] Make and Model No. should be quoted with detailed specifications (brochure) and rates of individual item / category wise.
- J] Valid solvency certificate equivalent to an amount not less than 25% of the estimated cost of works from scheduled / nationalized bank.
- K] The competent Authority reserves the right to relax any of the above conditions without assigning any reason thereof. Interpretation of the authority will be final.
- L] The qualified bidder should show three sample and get approved by the Superintending Engineer. The price bid will be opened only after the verification & approval of the Sample.

SPECIFICATIONS FOR RAIN SUIT (JACKET WITH HOOD AND LEGGING)

1. DESCRIPTION AND DESIGN :

Gents Jacket with Detachable hood and separate legging having fabric surface on the outer side. The waterproof fabric used in single texture type-Grey color, rubberized material quoting inner side of polyester fabric dyed in Grey color.

Front part of jacket is made of two pieces stitched with two sleeves at shoulder. The back part is of single piece construction. The front part of the Jacket is fitted with module chain having a cover. The hood can be attached to the Jacket by using press type buttons or stitched and is also provided with tying tag. Elastic type provided at sleeve end in Button edge of Jacket.

Logo of the Company / Board on front left side of the Jacket and name of the

Company / Board on Back side of the Jacket in CAPITAL (MAHATRANSCO).

2. Rubber Polymer content of the proofing shall be 35% Minimum as per IS: 5915 OF 1970.
