1. The rate shall be quoted on firm quotation basis.
2. The rates should be quoted excluding / including of taxes. The taxes if any should be quoted extra.

4. Your quotation should reach this office **on or before 06.12.2017 up to 17:00 hrs** and the same will be Opened on the same day, if possible.
5. The rates shall be quoted **excluding or including GST in Percentage Only** on **Total amount of the schedule**. The rates and amount shall be written both in Words and figures. The rates shall be written legibly and shall be free from eraser. The rates quoted shall include all the machineries, T&P and personnel required for executing the works.

- c. Inspection of Tension clamps, tower peak nut bolts, cross arm nut bolts and total cross arm inspection,
- d. Inspection of disc insulators, position of armoring rod, inspection of suspension / tension / pilot strings, inspection of pin position of disc insulator.
- e. Inspection of top middle and bottom structure nut bolts of tower, conductor vibration damper, bird guards, corona jumper nut bolt etc. and all tower accessories must be inspected and **defects noting with photos and if necessary video recording with requirement as per the directives of Line Incharge.**
