### **Terms & Conditions**

The quotation should be sent under sealed cover duly super scribed as QUOTATION for Carrying out Work of Transportation of 25MVA, 220KV/33KV Vijay Make Power Transformer from 220KV Narsi Sub-Station to 220KV Krushnoor Sub-Station, to Executive Engineer EHV Project Division, 132Kv Jangamawadi s/s campus area, Nanded. The quotation should reach this office on or before 29.11.2017 up to 17:00 Hrs and the same will be opened on the same day, if possible. The Quotation received after due date will not be considered. This office is not responsible for any postal delay.

- 1. The quotation must be forwarded in sealed envelope duly super scribed with all details i.e.
  - I. Enquiry No. & Date : II.Due Date: III.Quotation for:-
- 2. The quotation must be written with ink or typewritten. Any as catching or over writing must be initialed.
- 3. The rates should be quoted inclusive/exclusive of all taxes. If nothing is mentioned about taxes, the rates may be treated as rates inclusive of all taxes.

#### 4. Scope of Work:

Work for Carrying out the Work of Transportation of 25MVA, 220KV/33KV Vijay Make Power Transformer along with accessories from 220KV Narsi Sub-Station to 220KV Krushnoor Sub-Station. (Schedule –A).

- 5. **Period of Work Completion**: The work shall be completed within 30 days from the date of handing over of site by the authority concerned incharge / Addl. Executive Engineer. The decision of the concerned in charge will be final in this regard.
- 6. Required Documents:-
  - 1) GST Registration with returns.
  - 2) Shop Act License.
  - 3) Valid Electrical License.
  - 4) PAN Card & PT Registration etc.
  - 5) RTO certificates related to transportation like Heavy driver license, vehicle fitness insurance etc with all documents for heavy loading of materials.
- 7. **Experience:** The agency must have experience of carrying out the similar type of work of Carrying out the Work of Transportation of EHV power Transformers & EHV Line & Substation materials.
- 8. **Risk:** M.S.E.Trans. Co. Ltd. does not take any risk and will not pay any compensation for fatal/non-fatal accidents. to persons deployed by you for the work, while carrying out the work under contract nor anything will be paid towards damages to your vehicle.
- 9. **Tools and Plants:** All tools, plants and machinery required will have to be arranged by bidder its cost.
- 10. **Technical Skilled persons:** The contractor shall depute skilled workmen for each class of work.
- 11. Income Tax: Income tax will be recovered from your bills as per rules.
- 12. The contractor should take all the precautions at his own cost until the site is handed over to the M.S.E.Trans. Co. Ltd.
- 13. **Computation of Distance:** The work of transportation should be done through shortest motor able road/ route. Kilometer indicator meter of vehicle should be always in good working condition. If it is found faulty, distance will be calculated as per PWD road map. One way Distance will be considered for passing the bills.
- 14. **Transport Permit:** Permission of transport of power transformers from *RTO/* PWD and other Departments, if necessary, is to be arranged by contractor at his cost.
- 15. **Payment**: 100 % payment will be done at the earliest depending upon availability of funds after work completion certificates from concern.
- 16. **Security Deposit**:-The Bidder has to pay @5% of contract values as the security deposit after the acceptance of the order.
- 17. **Penalty:** If the work is not completed within stipulated period the penalty @ 1 % per week subject maximum 10% of the value of work order will be levied.
- 18. **First Aid Box**: The contractor should always keep and maintain "First Aid Box" for this work as safety measure.

- 19. Accident: If any accident occurred to your labors skilled or unskilled, during transportation, loading unloading or winching etc. compensation if any has to be paid by you only.
- 20. Damages:-Any loss, damage to the material and other MSETCL's property occurs during execution of works, is subject to recovery as per MSETCL's rules from you.
- 21. **Discretion**:-The undersigned reserves the right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever. The contract can be terminated by the authority at any time, without assigning any reason by giving one day advance notice.
