Scope Of Work:- Repairing of control & Relay Panels including supply of panel locks, vermin proofing ,metal sheet etc installed at 400KV & 220KV GCR Koradi sub-station under 400KV RS (O&M) Dn Nagpur.

TERMS & CONDITIONS

- 1. **RATES:** RATES should stand firm for 6 months.
- 2. <u>TAXES & DUTIES</u>: The rates are accepted inclusive of all taxes, duties, levies etc imposed by Centre, State Govt., Local Authorities, transportation.
- 3. **VALIDITY OF WORK ORDER**:- 6 months from date of dispatch of Work order/LOA.
- 4. <u>PAYMENT</u>: Payment of work will be made after receipt of Tax invoice only in triplicate, after satisfactory Completion of work for each Sub-Station duly entered in M.B. and SERVICE ENTRY or GR in SAP system and certified by concerned Sub-Station In-Charge, Subject to availability of funds. Agency will have to submit the Tax invoice in triplicate to the concerned Sub-Station or to Division Office, indicating PAN No, Service Tax number, along with service report made with Substation Engineer/In-Charge. All the payments will be made by Account Payee Cheques only. Payment at request of the vendor can be made by Demand Draft payable at cities outside the concerned pay office, subject to deduction of D.D. charges from the agency's bill.
- 5. LOCATION WHERE SUPPLY TO BE CARRIED OUT: At 400 /220 KV Koradi Sub-Station.
- 6. **WORK COMPLETION PERIOD:** After dispatching of order within 2 month.
- 7. **PENALTY:** IF work is not carried out within stipulated period , penalty @ ½% per week up to maximum of 10% of the total value of order will be payable by the contractor. In case of maximum delay, the contract may be terminated by the undersigned and the balance work shall be got completed at your risk and cost.

- 8. **SECURITY DEPOSIT**: The Agency will have to pay an amount equal to 5% of amount of order towards SECURITY DEPOSIT in the form of CASH/ DEMAND DRAFT as per order conditions which is refundable after satisfactory completion of work.

The undersigned will reserves the right to carry out the work from other party if the services not offered from you within stipulated period during the guarantee period and the charges paid to other party will be recovered from your EMD or S.D. amount.
