Sealed and superscribed quotations are invited by the undersigned for the above work as per the Schedule 'B' enclosed so as to reach this office on before **15.12.2017** upto **13.00** Hrs. The quotations would be opened on the same day if possible.-

### **Terms and Conditions:-**

- 1) Work is to be done at: Supply order of Safety Shoes, for the Employee working under EHV CCCM Division office, Pune.
- 2) Work is to be completed within **30 Days** from the date of handing over of site. If it is not completed within this period penalty will be charged at the rate of one percent per day maximum upto 5 % of estimated cost.
- 3) Quantities mentioned in Schedule 'B' are approximate and payment will be made on actual quantities executed.
- 4) Payment will be made in R.A. Bills or only first and final bill at the direction of Engineer-In-Charge.
- 5) Rates quoted shall be inclusive of all taxes like GST.
- 6) No T & P, Labour etc. will be supplied by the Department.
- 7) Work is to be carried out strictly as per the standard specification and as directed by the Engineer-In-Charge. Mode of measurements will be as per P.W.D. / B. & C. Department practice.
- 8) In case of any dispute decision of the Ex. Engr.(Civil) will be final and binding on the Contractor.
- 9) If any damages occur to the M.S.E.T.C.L.'s property, during execution, contractor will have to make them good at his own cost.
- 10) Income Tax at 2% of gross bill would be recovered from you in case the order value exceed Rs.30,000/-.
- 11) The rates quoted should also be written in words & inclusive of all Taxes.
- 12) Overwriting and corrections, if any, shall have to be initiated by the contractor.

- 13) Agency has to submit the Certificate of Experience for execution of same works in Govt. organization duly signed by the officer not below the rank of Executive Engineer or equivalent in case of Govt. works
- 14) Contractor is requested to visit/inspect the site before submitting his quotations.
- 15) Contractor will have to pay 5 % Security Deposit before starting the work only.
- 16) Contractor will have to sign every page of Schedule 'B' attached.
- 17) Right to reject any or all quotations without assigning any reasons is reserved.
- 18) All terms & conditions as per the Board's rule including those in the M.S.E.T.C.L.'s booklet for "Tender and Contract for Works" are applicable in this case also.
- 19) You should submit duly attested certificate like Shop Act, GST, Pan, etc. as per govt. requirement.
- 20) You are requested to submit the duly attested copy of GST registration certificate and whole responsibility of paying GST to Govt. Department lies on you.
- 21) You should submit valid registration certificate along with quotation.
- 22) Jurisdiction of Court for Dispute, yielding Court case if any arises Jurisdiction of Court shall be Pune Dist. Pune.
- 23) Agreement Bond on Stamp paper of Rs. 500.00 should be executed after placing of work order & payment of any bill against this work order.
- 24) In case the material is not received within delivery period as above, you will be liable to pay a penalty to the company from ½% per week on the price up to maximum of 10% reckoned on the total value of the order.
- 25) You have to submit the Guarantee Certificate against the material. The material supplied by you should be good and guaranteed for 12 months against manufacturing defects etc.
- 26) You Should supply the material as per approved sample submitted by you i.e BATA MAKE, with ISI mark on each sole of shoes, as per IS 15298 (Part-2)/ISO 20345:2004, SB CM/L: 5428669, Government of India (DGMS), classification no.825-6050-ST, Approval No.SA-6/2010. Low ankle, steel toe cap with light weight, Electric shock proof with injection mounded PV sole, bartain leather, upper resistance to oil, acid and alkali and if the goods are found defective or other than the approved sample, the same will be rejected and you will have to replace them free of cost. If the supplied material is not found as per specification during the Guarantee period then you will be penalized as per MSETCL rules and regulations.
