1) **Due Date:-** The prescribed form i.e. Schedule A duly filled in with the rates written in both numbers & numerals i.e. in words & figures; & duly signed & stamped by the signatory authority should reach this office on or before 21.12.2017 at 11.30 Hrs.

- 2) Sealing & Super scripting: The offer should be sealed in sturdy envelope & should be super scribed by:-
  - (a) Subject of this enquiry.
  - (b) T.O. Outward No. & outward date of this enquiry.
  - (c) Due date of submission of this enquiry as mentioned in condition (1).
- 3) <u>Other Conditions:-</u> The offer should be submitted along with following conditions & documents :-
  - (a) Rate validity of the offer.
  - (b) Inclusion of GST & applicable taxes.
  - (c) Shop Act.
  - (d) Pan Card.
  - (e) GST registration details.
  - (f) Warranty/Guaranty against repairs.
  - (g) Experience of similar nature of work not below the rank of Ex. Engineer in Govt. or Semi- Govt. undertaking.
- 4) Security Deposit:- The successful Bidder shall have to pay 5% of the contract value towards security deposit within 15 days from the date of acceptance of his offer. The amount will be refunded in the normal course, after expiry of the contract period subject to deduction, if any.
- 5) Interest: No interest will be allowed on this S.D. On the breach of contract during contract period S.D. will be forfeited without assigning any reason.

- 6) **<u>Rate Validity</u>:** The offer shall be valid for acceptance for a minimum period of 60 days from the date of submission of the offer. During this period no bidder shall be allowed to withdraw his offer. Such withdrawal during the said period shall result in the forfeiting of SD.
- 7) Period of Order: Period of order will be upto 2 months.
- 8) <u>**Tax Invoice:-**</u> Tax invoice should be submitted along with warranty/ guaranty of work (with Sr. no. of repaired equipment) & must contain Pan No., GST no. along with HSN/SAC code.
- 9) **<u>Payment:</u>** Payment along with applicable GST shall be made after successful completion of work, due recording and scrutiny of the tax invoice by EHV O&M Circle, Pune.
- 10) <u>General Conditions:</u> The MSETCL's general conditions for work contract are also applicable & will be binding on bidder.
- 11) **<u>Right of acceptance/rejection:</u>** The undersigned reserves the right to continue or terminate the offer without assigning any reason thereof.
- 12) <u>Agreement</u>: On assigning the work order an agreement is to be executed with Executive Engineer, Testing Dn. Pune on stamp paper of Rs.500/-. The cost of stamp paper will be borne by agency.
