- 5) Quotation shall be sent under sealed cover duly subscribed as our Enquiry No & Quotation for "E-enquiry for the work of HT LT line shifting at village Borgaon & Bondale Tal-Malshiras, Dist-Solapur" in block letters.
- 6) The service provider should provide similar work experience certificate.
- 7) The offer shall be valid for acceptance for the period of **3** months from the date of submission.
- The entire work as per the scope in schedule "A & B" is to be completed within a period 8) of 15 days from the date of handing over of the clear site for work.
- 9) All the documents i.e. PAN card, GST registration, etc. and other accompanying documents like Shop Act, Electrical Contractor License shall bear the authorized signature of agency, failing which the offer will be liable for rejection.
- The material shall be guaranteed for a period of One year (O1 Year) from the date of 10) supply. If any defect is observed during guarantee period the same will have to be replaced / attended free of cost or as specified by manufacturer whichever is higher.
