- 1.0** The Maharashtra State Electricity Transmission Company Ltd., Mumbai, hereinafter referred to as the 'Owner' (MSETCL) invites offers in TWO bid system (Techno-commercial and price bid) from the eligible registered bidders for the following scope on turnkey basis as detailed below.

The **owner has SRM e-tendering system for turnkey contract works**. The bidder has to upload the complete bid proposal in two parts (**Single stage-Two bids system**) i.e. techno-commercial bid and price bid through SRM e-tendering before due date and time. **The bid documents submitted through SRM e-tendering shall only be considered for evaluation.**

- ) The prices to be quoted against this IFB shall be in Indian rupees only.
- ) The tender is invited **on individual percentage basis divisible for Supply, Erection & Civil with equal loading on all the items.**

- ) The contract value shall be decided on the basis of unit rates for supply, erection & Civil indicated in schedule-H (Volume III – Price Schedules-Detail breakup) with % (percentage) above/below offered and equally loaded on all items by the Bidder and accepted by MSETCL. Also, the Bidder shall submit the Abstract of their quoted offer as per Schedule B (I).
- ) For Evaluation of the Tender, the total price of Supply, Erection & Civil including all Taxes & Duties shall be considered.
- ) The LoAs will be placed on final accepted price for Supply, Erection & Civil including all applicable Taxes & Duties.
- ) Variation in Taxes & Duties if any will not be payable.
- ) The bidder has to submit detail price break up at the time of bid submission. In case the break up is not submitted by the bidder, the bid price will be considered on firm basis with no Price Variation clause.
- ) Price variation shall be given on Ex-works price mentioned in MSETCL's estimation or bidder's ex-works/ CIP quoted price whichever is lowest. For extra items rate shall be as per approved MSETCLs latest SOR or as reasonable.

The brief scope of the work will be as under:

- a) Fabrication & supply of towers as per owner supplied tower designs , with required extensions, design of special towers (if required), modification / strengthening of towers (if required), design of foundation (if required), supply of Bolts & Nuts, Conductor, Earthwire, Insulators, Insulator Hardwares, Tower Accessories, Conductor & Earthwire accessories etc. required for completion of the line.
- b) Clearing of site, casting of tower foundations (including stub setting), Design of pile foundations & special foundations if required, erection of complete towers with extension & all accessories, hoisting of insulators, stringing of conductors & earth wire lines as per specification, fitting of line hardwares, tower accessories etc. and all other materials and accessories required for completion and commissioning of the line.
