Sealed quotations invited for the supply of material as per specification mentioned in the enclosed Schedule 'A' with following terms and conditions. The quotations should reach to this office on or before **dttd:29.01.2018** upto 17:30 hours.

Terms and Conditions:

- 1) The quotation shall be sent in sealed cover, clearly superscribed with the words "quotation for supply of STN & DTN hardwares suitable for 0.2 ACSR conductor required for 132 KV Oglewadi – Mayani line. Quotation without superscription is liable for rejection.
- 2) The quotation should be addressed on designation of the Executive Engineer EHV Projects Dn., Sangli, 2nd Floor, Administrative Building, Vishrambag, Sangli-416415.
- 3) The rates quoted should be including the packing, forwarding, freight, insurance, transportation charges, labour charges, labour cess as per requirement.
- 4) **Mode of Destination** - Material should be supplied at 220 KV Oglewadi site store, Tal. Karad, Dist. Satara in consolation with respective site in-charge for 132 KV Oglewadi - Mayani line.
- 5) **Work Period:** The work should be completed at 132 KV Oglewadi – Mayani line within 15 days from the date of receipt of firm order, otherwise penalty as per MSEB's rules will be levied.
- 6) **Rates** : Rates should be firm and FOR destination.
- 7) **Quantity** : The Quantity mentioned in the Schedule 'A' is tentative and subject to variation on either-side. However, payment will be made for the material actually received.
- 8) **Payment:** Payment will be released as early as possible against M.B. recording. No advance payment will be released against dispatch documents.

- 9) **Required Documents** : Please attach the following documents alongwith quotation –

 - e) Experience Certificate for similar work in MSETCL or other Govt. U/T Tr. licensee. The experience certificate should be issued by the Ex. Engineer, equivalent or above.
- 10) **Guarantee** : Guarantee of supplied material should be 1 year from date of supply.
- 11) **Validity**: Quotation should be kept valid for at least 45 days from due date.
- 12) Quotation received late / with incomplete details against above clauses will not be considered.
- 13) Right to reject any or all quotations without assigning any reasons there of reserved by the undersigned.
- 14) Contractor itself should aware to all terms and conditions of MSETCL's erection and supply terms & conditions.
