# TERMS AND CONDITIONS OF CONTRACT

### 1) SIGNING OF CONTRACT:

Within 7 days from the date of the receipt of this work order, the contractor shall enter into an agreement with the Company, in the prescribed format. Unit the agreement is executed, the company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

### 2) SCOPE OF WORKS:

The scope of works includes providing of ITI Operators for various EHV S/Stns under EHV O&M Division office Sangli. The desired qualification of the outsourced employees shall be as prescribed below.

<u>Operator</u> :- ITI certified Operators in Electrician Trade with NCTVT. Candidate should possess minimum two year experience working in S/Stn. The Contractor should arrange to obtain the authorization from the Competent Authority for operating 220/132/110/33/22KV Sub-Station equipments. While the other safety tools will be provided from MSETCL Company side, the Operators deployed should be provided with proper safety shoes.

The expectations from the deployed are

i) They shall be experienced in operating HV/EHV switchgear.

ii) In good physical & mental health, devoid of bad habits like drinking etc.

iii) Polite & well behaved.

iv) Between 18 & 40 years of age.

#### 4) SECURITY DEPOSIT:

You should pay security deposit equivalent to 5% of the value of the order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work

#### 5) CONTRACT PERIOD:

The contract period shall be operative for **10 Days** with effect from the date of issue of *Final Order/LOI* or till the exhaust of order amount.

## 6) OPERATING AUTHORITY:

The Executive Engineer, EHV O&M Dn. Sangli will operate this contract.

**7) PAYMENT OF BILL:** The monthly bill in triplicate should be submitted to the EHV O & M division office Sangli at the end of each month along with the duty chart for the month. The Division office will effect the payment.

## 8) PENALTY FOR DEFAULT:

Penalty @ 1% per day/part of payment approved rate thereof subject to maximum 10% of order value will be deducted from your bills as penalty in case you default in providing ITI Operators during contract period. The deduction will be limited to the actual period of default.

### 9) TAX DEDUCTION AT SOURCE:

i) In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source, (such as W.C.T.) if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government.) will also be deducted from the bills at the prevailing rates.

ii) The GST Tax Liability of Service Recipient (MSETCL) will be paid by MSETCL as per Reverse Charge Mechanism under GST Tax Act.

**10)** Out-Sourcing Staff cannot claim in future for job in MSETCL. Undersigned reserves the right to disqualify outsource staff.

#### 11) DAMAGE TO PERSONS AND PROPERTY:

The contractor shall indemnify the MSETCL against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the execution of the work.

#### 12) TERMINATION OF CONTRACT:

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract and unsatisfactory services in any respect.

#### 13) JURISDICTION:

All disputes, differences related to the contract shall be subject to the including jurisdiction of Sangli Court.
