1) Submission for bids :-

A. Techno-commercial bid :- this should contain following documents/certificates as a proof of qualifying pre-requisites, brochures, attested certificates etc.

If validity of any license/certificate expires during order period, you will have to renew the same and submit the copy to this office.

B) The offer shall be valid upto 120 days from the date of opening of the quotation/commercial bid.

C) Conditional offer will not be accepted.

2. **Nature of work** :- Tree trimming & grass cutting around fencing of 400KV & 220 KV switchyard and approach road of 400 KV R.S. Lonikand –II S/s

3. **Supervision of work** :- The work shall be supervise by Addl.EE (Maint.) Lonikand 2 or his representative as per specification.

4. The estimated rates given by this office are inclusive of taxes. Hence bidder should quote rates inclusive/exclusive of taxes. If bidder quote rate exclusive of tax , then taxes should be quoted separately.

5. Required transportation arrangement of material regarding to work shall be on contractor's account.

6. **Penalty** :- In case of failure to complete the work as per our description, contractor will be liable to pay penalty at rate 1/2% per week of order value subject to maximum 10% of order value .

7. Payment will be made after completion of the work by A/c. Payee cheque only after receiving the necessary certificate from engineer In charge regarding satisfactory completion of work. You have to submit the bill in triplicate to this office by mentioning your Service Tax & PAN No. etc .
8. The agency should carry out the work in the premises of 400 KV Lonikand –II S/stn under the supervision of Add.EE.(M) or his representative as per specification mentioned in Schedule A .
9. The contractor shall not be entitled to claim any interest on amount payable to him. The sub contract against the order will not be accepted .
10. Contractor should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
11. Statutory taxes will be deducted from bill as applicable
12. In case of difference of opinion, misinterpretation of any of the condition of the contract. In connection with or arising out of the condition or during the work period, the decision of the undersigned shall be final and binding on you.
13. Jurisdiction :- All disputes, differences related to the tender contract shall be subject to the exclusive of jurisdiction of Pune District court.
14. Contractor can be visited to 400KV S/stn Side inspection before submitting the quotation.
15. **Security Deposit:** The bidder will have to pay the security deposit of 5% of the amount of the order within 10 days from the date receipt of this order, by Cash/DD/FDR to this office.
 - B As per circular no.2578 dtd 28.07.14 if security deposit is not paid within 10 days, 18% interest will be charged on the work order value.
 - C Also the bidder will have to apply for refund of S.D. within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the actions as per C.O's rule will be taken.
 - D The Security deposit will be returned after the completion of the work satisfactory and N.O.C is necessary for refund of Security Deposit/Bank Guarantee, it should be taken from concerned Executive Engineer by the contractor. No interest will be allowed on this deposit.
