2. **Quoted rates:** the taxes applicable if any should be quoted distinctly.
3. **Delivery period:** the battery should be replaced within 15 days from date of issue of work order.
4. **Penalty:** if the material is not replaced within stipulated time, penalty at the rate of 1/2% per week, subject to 10% maximum order value will be recovered from your bill.
5. **Terms of payment:** 100% payment will be effected to you, subject to availability of funds.
6. **Payments:** the bills in duplicate should be submitted to this office for payment, with necessary documents as Manual , guarantee / warranty card etc. F&A section Head, EHV O&M Circle, Kolhapur will certify and record the bills in MB against the supply of scanner.
7. **Guarantee / Warranty:** you have to furnish the gaurantee / warranty of material as per manufacturing standards from the date of receipt of material against any manufacturing defect etc. The understanding as such should be sent alongwith the bill.
8. **Quality of materials:** the quality of material should be as per specification in Schedule A.
9. **Jurisdiction:** all disputes or difference arising out of this order for supply, if concluded shall subject to exclusive jurisdiction of Kolhapur court only.
10. **Security Deposit:** you have to pay security deposit of 10% of order value in form of cash / DD / BG which will be refunded after completion of warranty period.

11. Consignee: the ordered material should be delivered to EHV O&M Circle office, Kolhapur.
12. If you fail to supply the material in stipulated time, material will be procured at your risk and cost.
13. You are also deemed to be fully aware of Company's general conditions for supply of materials.
14. You should have to submit following documents:
