1) SIGNING OF CONTRACT:

Within 7 days from the date of the receipt of this work order, the contractor shall enter into an agreement with the Company, in the prescribed format, the agreement is executed, the company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

2) SCOPE OF WORKS:

The scope of works includes providing of Computer Operator, LDC & Un-Skilled Peons for various sections & S/Dns under EHV O&M Division office Sangli. The desired qualification of the outsourced employees shall be as prescribed below.

* Computer Operator (Steno-Typist, Typist):- Should have Graduate at any

stream with MS-CIT Pass

* Peons :- Should be able to Read & Write Marathi

* LDC :- Should have Graduate at any stream with MS-CIT Pass

4) SECURITY DEPOSIT:

5) CONTRACT PERIOD:

6) OPERATING AUTHORITY:

The Executive Engineer, EHV O&M Dn. Sangli will operate this contract.

7) PAYMENT OF BILL:- The monthly bill in triplicate should be submitted to the EHV O & M division office Sangli at the end of each month along with the duty chart for the month. The Division office will effect the payment.

8) PENALTY FOR DEFAULT:

Penalty @ 1% per day/part of payment approved rate thereof subject to maximum 10% of order value will be deducted from your bills as penalty in case you default in providing Computer Operator, LDC's & Un-Skilled Peons during contract period. The deduction will be limited to the actual period of default.

10) Out-Sourcing Staff cannot claim in future for job in MSETCL. Undersigned reserves the right to disqualify outsource staff.

11) DAMAGE TO PERSONS AND PROPERTY:

The contractor shall indemnify the MSETCL against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the execution of the work.
