**Terms and Conditions :-**

1. The time limit allowed for completion of the above work is **15 (Fifteen)** days from the date of handing over of site, failing which the contractor shall be liable to pay compensation amount equal to 1% of the cost of the whole work or such smaller amount at the discretion of the undersigned, every day that the work remains incomplete or unfinished after due date of completion, subject to the maximum of 10 % of the cost of work order.
2. The quoted rates are inclusive of all taxes. All other taxes such as I.T., GST are applicable. Nothing extra will be paid on any account.
3. Income Tax will be recovered from the bill on the total value of the work done, as per the prevailing rates for which certificate, if needed will be issued from this office.
4. The contractor shall have to enclose Govt. Deptt's registration copy, GST Registration copy and work done certificate of civil works along with quotation.
5. The work should be carried as per the standard specification mentioned in the latest edition of PWD standard specification Books, and to the satisfaction of the undersigned.
6. All tools and plants required for the said work shall be contractor's own.
7. Contractor will have to make good damages, if any done by you to Company's property during the execution of entire work at his own cost.
8. The quantity mentioned in the attached Schedule are approximate and may increase or decrease during the course of execution. Contractor has no claim for any alteration. However, Payment will be effected as per the actual measurements of work executed.
9. The undersigned have the right to slightly alter the clause of work without involving financial implications on either side.

10. Rates should be written both in figures and words in ink only. Corrections if any be scratched and rates should be re-written with dated initials.
11. Contractors will have to pay Earnest Money Deposit of **Rs. 5000.00** in cash in Division office or through Demand Draft drawn in favor of Executive Engineer (C) EHV CCCM Division, MSETCL, Latur. Mode of payment of EMD with MR. No. Date etc. should be written on the sealed envelope of quotation.
12. Contractor will have to pay the security deposit equal to 5% of the value of order within Ten days from the date of receipt of work order, in the form of cash at the office of Executive Engineer (C), EHV CCCM Division, MSETCL, Latur.
13. Contractor will be held responsible for accidents during the entire course of work and he will have to pay compensation whatsoever as per the prevailing Workman Compensation Act.
14. All the terms and conditions laid down in “ MSETCL, Booklet for the Works Contract” stands applicable for this work.
15. Security Deposit will be refunded after satisfactory completion of work and expiry of prescribed maintenance period.
16. Maintenance period will be of 90 days.
17. GST will be deducted from your bill as per the prevailing rules.


