GENERAL TERMS AND CONDITIONS

ATTENTION of the tenderer is specifically invited for the compliances of the following requirements at the time of the submission of the tender. If these requirements are not fulfilled, tender will be *liable for rejection*.

- 1. Tenderer must be registered in MSETCL for SRM E-tendering.
- 2. Offer should be submitted through e-tendering system only in two bids. The e-Tender is to be submitted online on website www.mahatransco.in / <u>https://srmetender.mahatransco.in</u>
- 3. The e-Tender signed with digital signature will be accepted up to due date & time of submission. It is highly advisable to submit the digitally signed e-tenders sufficiently in advance of due date & time, so as to avoid last minute trafficking at server. MSETCL will not be responsible for non-submission of the bid due to internet related problems or any other technical issues at bidders end.
- 4. The e-Tender fees once paid against the particular e-tender (**RFx**) will not be refunded / transferred or adjusted at all. The sale of tender will be in electronic format only on payment of the online e-tender fees.
- 5. In qualifying bid you should submit the documents as per Qualifying Conditions. If relevant documents are not provided , the bidder will be disqualified without any further notice.
- 6. The Annexure "A" duly filled in shall also be submitted with qualifying bid.
- 7. In Price/Commercial bid the bidder should submit the prices online on E-tender portal. The rates should be quoted up to two decimals only. Every care shall be taken by the bidder while submitting the prices.
- 8. The qualifying bid will be opened first and if found eligible then the corresponding price / commercial bid will be opened for further consideration.
- TENDERER should <u>carefully read</u> all the TERMS AND CONDITIONS/ INSTRUCTIONS of the TENDER DOCUMENT and follow the same scrupulously. In case of any omission, the TENDER shall be liable for rejection.

10. <u>In case of any doubt in respect of any schedule or clause, it should be got cleared in writing from the office of the undersigned before submitting the TENDER (RFx) OFFER. Any complaints in this regard will not be entertained after etender submission date or opening of TENDER (RFx).</u>

- 11. Rates: The estimate is prepared inclusive of taxes thus the rate should be quoted by the bidder inclusive of GST in the SRM software system. The rates quoted shall be valid till complete work is executed and the rates quoted shall be firm for at least six months whichever is later.
- 12. The work shall be immediately taken in hand for earliest completion. Specific work completion conditions will be incorporated in the detail purchase order. Considering the genuine site conditions/difficulties the work completion period can further be extended as per the recommendations of concerned Sub Station Engineer Incharge.
- 13. Security Deposit: You will have to pay S.D. equivalent to 05% (Five percent) of the order value after receipt of the order within 10 days to this office by D.D. / B.G. or by cash. If S.D amount is not paid, the purchase order will be cancelled without any further communication. The payment of SD as above is mandatory and binding. No plea of the agency will be entertained for deducting the SD amount from bills.
- 14. **Tender Fees & Earnest Money Deposit payments:** Tender fees & EMD will have to be paid by the bidder through ONLINE payment mode only.

In no case exemption for payment of earnest money will be granted, except in case of SSI Units. As such the bidder is requested not to make any request for exemption of tender fee / EMD. The tender without online E.M.D. / tender fee payment will not be considered in any case. The tender fee and EMD payment shall be done on or before the due date/time of sale of bid. Hence the bidder shall take correct note of all the date's & time of the bidding processes. EMD will be refunded only after 90 days.

SSI unit is not required to pay the EMD amount as per prevailing Govt. Norms. EMD and Tender Fees should be paid by the bidder on line. This money will not bear any interest. In case of successful bidder the earnest money will be refunded only after payment of the security deposit. The E.M.D. to the unsuccessful bidder will be refunded only on production of online transaction ID along with bank details.

Note: Earnest money deposited will be refunded online through SRM System after approval from competent Authority. EMD will be credited to the bank account maintained by bidder in vendor profile in SRM system. Bidders are requested to ensure that the bank details i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address are correctly maintained in SRM System and update the same, if required.

It may be noted that:

- i) In case bank details are not maintained by the bidders in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay.
- ii) MSETCL will not be responsible for any financial implications in case incorrect bank details are maintained by the bidders as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.
- 15. Validity: The tender submitted shall be valid for 90 days from the date of opening. The bidder will forfeit the right to the earnest money deposited by him in case the tender is withdrawn after the opening date and before the expiry of 90 days or in the event of refusal to accept the order or not to execute the order and to pay the Security Deposit within the stipulated period.
- 16. The C.A. & (F&A) Section Head will open E-tenders online in SRM E-tender system. The Executive Engineer, EHV O&M Dn., Wardha is the C.A. for this tender.
- 17. Agreement: The Contractor will have to enter into an Agreement with the Company to carry out the contract in the prescribed form on non-judicial court stamped paper of appropriate value as per MSETCL's Adm. Circular No.207 Dt.17.04.2010. The cost of the stamp paper will be borne by the Contractor.
- 18. Income Tax Clearance: The tenderer is requested to note that income tax @ 2.0% or as per the applicable rate of the gross bills payable will be deducted while making payments by this office to contractor. Income Tax deducted at source certificate (T.D.S.) /necessary certificate will be issued to the contractor. If any new tax is incorporated by Govt. in near future, it will be applicable to all works as per the prevailing law of the land.
- 19. The **taxes** applicable as per prevailing rate will be deducted from your bill.
- 20. The Registration No. under GST Act may be quoted.
- 21. The **employees of the agency will not be entitled for any facility** as is being provided to MSETCL staff. It is the sole responsibility of agency to observe and abide by the provisions of Labour Acts such as Workmen Compensation Act, Minimum Wages Acts, Payment of Wages Act, Gratuity Act, P.F. Act, GST Act and other regulations framed by the Govt. from time to time. MSETCL will not be responsible for any violation of the Act or Regulations by the agency.
- 22. The **agency will be responsible for compliance of all statutory obligations** under the Factory Act, Contract Labour Act, Minimum Wages Act, Contribution under the C.P.F. Professional Tax, C.P.F. & E.S.I.S. Act etc., in respect of his employees. The payment, monthly/weekly to the staff of agency shall be made as per prescribed Minimum Wages Act in presence of authorized representative of MSETCL.

The agency shall prepare a wage cum attendance register in the format given in Minimum Wage Act 1948. Any deviation to the above may result in suspending payment of bill of Agency by MSETCL.

- 23. Liabilities & Responsibilities of the Contractor:-The Contractor will be responsible for the payment of compensation to his staff in case of accidents as may be admissible under the Workmen's Compensation Act, 1923. If he fails to pay the same, it will be recovered from any of his bills due for payment to him by the Company and will be paid to the concerned persons or his dependent/heirs/Govt. Authority etc., as required under the rules and regulations. The Contractor will have to insure all his staff under Workmen's Compensation Act and the copy of the same will have to be produced to the contract operating Authority, Failing which the bill will not be released.
- 24. **Subletting of contract** in any form to other contractive agency will not be permitted.
- 25. Jurisdiction All tender disputes or differences arising out of or in connection with the contract, if concluded shall be subject to the exclusive jurisdiction of Wardha Court.
- 26. All required **Original certificates if required by the competent authority of MSETCL** will have to be produced by the bidder.
- 27. In case the tenderer fail to enclose all the necessary and correct documents, the tender application, at the discretion of Competent Authority of MSETCL, may be rejected without further consideration. However, MSETCL may call additional documents at the discretion of its officers. If any condition of the qualifying conditions is not applicable, the bidder shall submit the undertaking for the same without fail with due justification. However decision of Competent Authority of MSETCL will be final and binding to the bidder for acceptance of such undertakings.
- 28. The Maharashtra State Electricity Transmission Co. Ltd., or their officers who accept the tender, shall have the right of rejection of all or any of the tender (part or full) and will neither be bound to accept the lowest, nor to assign any reason whatever for the rejection of any tender or all tenders in the interest of MSETCL.
- 29. Submission of tender offer in SRM e-Tendering system by a bidder implies that the bidder has read all the instructions and conditions of contract and has made himself aware of the scope and specifications of the work to be done, of the conditions and rates at which stores, etc. will be issued to him and local conditions and other factors bearing on the execution of the work. Also, Submission of tender offer in SRM E-Tendering system by a bidder implies that the bidder has read all the terms and conditions (all pages) of the tender document.
- 30. The **conditional tender** will be liable for rejection.
- 31. The **Solvency certificate** issued by the bank **shall not be older than one year**.
- 32. Language of tender:-All proposals and information in the tender shall be in English.
- 33. The Firm/Contractor should be registered with respective Govt. Authority as per existing rules.
- 34. Force Majeure:- The completion dates as specified shall be subject to force Majeure herein defined as.
 - a. Any cause which is beyond personal control of contractor or the Company as the case may be.
 - b. Acts of any Government and authority domestic or foreign including, but not limited to war declared or undeclared, guarantees, embargoes etc.
 - c. Licensing control, production or distribution restrictions.
 - d. Accidents and disruption, including but not limited to fire and exposures.
 - e. Strikes slow down, lockouts, riots, grave disorders and sabotage affecting the work of contractor or Company.

The party affected by force majeure will notify the other party thereof immediately with sufficient profounder. For such circumstances reasonable extension for commissioning dates and starting and completion dates stipulated should be revised as mutually agreed upon.

- 35. The Maharashtra State Electricity Transmission Co. Ltd., or their officers who accept the tender, shall have the right of rejection of all or any of the tender (part or full) and will neither be bound to accept the lowest, nor to assign any reason whatever for the rejection of any tender or all tenders.
- 36. Any point to be specifically highlighted / elaborated or quoted, shall be clearly mentioned during the submission of the offer. Post thoughts / findings or appeals by the bidder will not be entertained. Hence the bidders shall carefully read all the pages, terms & conditions of this tender booklet.
- 37. Under no circumstances shall any contractor be entitled to claim enhanced rates for any items of contract without prior sanction of the competent authority.
- 38. In normal cause, the interpretation of the undersigned on any matter or decision given by him on any disputable point will be final and binding on the contractor.
- 39. The complete tender process is through SRM E-tendering system only, hence the E-tender document does not require the signature of competent authority.
- 40. The bidder shall not wait for the last date/time of submission of bid and ensure all efforts for the bid submission well before the due date/time. This office will not entertain any plea of the bidder for not been able to submit the bids due to website problems or otherwise.
- 41. In view of restructuring of MSEB into four Companies w.e.f. 06.06.2005 all the terms and conditions of the Board will hold good for newly incorporated company vide Registrar of Companies Certificate No. U40109 MH 2005 PTC 153648 and nomenclature as the "Maharashtra State Electricity Transmission Co. Ltd."
- 42. Quantity: The Competent Authority may delete or add the items in the schedule (Price Bid) and reduce or increase the quantity specified in schedule / detail order as per the actual requirement at site, even before finalization of tender/ Purchase order. The Lowest bidder will be finalized on the basis of the item wise/schedule rates received to MSETCL for the actual Supply / Work required to be executed at the time of giving L.O.I / detail order. The decision of the C.A. on deciding the lowest bidder will be binding on the bidder / contractor. Hence the item wise rates should be quoted carefully by the bidder. 50 % extension to the original order may be accorded if there is site requirement. The Agency will have to execute the order accorded under 50% extension in the same rates or lower rates at that prevailing time, whichever is lower.
- 43. Safety:- The contractors should provide all safety equipment / Tools & Tackles required for the work to his workers. If any accident occurs due to non-supply of these equipments or careless handling of equipment, the same shall be in the contractor's risk and cost. The contractor must maintain one first aid box in safe custody during the execution of work at site. MSETCL will not be responsible for any negligence on the part of contractor or contractor's personnel.
- 44. Stacking of material:-The Agency will have to stack any material loose or complete at safe location / place during/ after work execution as per directives of concerned Sub-Station Incharge / Executive Engineer. The Agency will not claim any extra charges for moving, shifting and stacking of material at site.
- 45. The tenderer must be registered under workman compensation act and the **employees shall be insured** under workman compensation act prior to start of work at site. For any accident the company will not be responsible for any compensation and all settlements pertaining to Govt. statutory payments shall be resolved by the tenderer only. The copy of <u>Valid Insurance of Labours</u> will have to be handed over to the SDO prior to start of work.
- 46. MSETCL will not be responsible for any accident (fatal or non-fatal) or injury to the personnel of the agency or any financial implication arising there from.
- 47. For any loss to the company's property during execution of work, the contractor will be liable to pay the equivalent compensation as per the recommendation of concerned Dy. Executive Engineer / Assistant

Engineer i. e the contractor will have to make good for all the material or pay equivalent amount as per present Market Rates.

48. It is the responsibility of the contractor to maintain the discipline of his staff and himself and any hindrance to the work will be viewed very seriously and will make the contract liable for the termination by the MSETCL without entertaining any claims from the contractor in this regard(Not applicable to contracts for supply of material at MSETCL stores).

1. Previous Experience: - The Tenderer is required to submit the *documentary evidences of previous* experience (Experience certificate) for the work of :-

"Work of Transportation/Winching, Loading/Unloading of Power Transformers, its accessories & Equipments/Materials of Substations/Lines".

Experience certificate shall be signed by the officer not below the rank of Executive Engineer.

The work is to be done on priority hence MSETCL intends to invite bids from bidders who are well experienced in above works. The bidder should have carried similar type of work with Power sector bodies of State Govt. / Central Govt. / PSU or Reputed Transmission Licensee. The bidder who does not have experience as above shall not participate in the bidding.

- 2. Rates: The rates quoted shall be valid till complete work is executed and the rates quoted shall be firm for at least <u>one year</u> whichever is later. The bidder shall include in the price schedule rates along with all taxes such as GST etc. / Octroi or any other fees or charges applicable by any Government, Municipality or any other authority. It shall be assured that the bidder's process cover all such taxes, duty/ fees and charges applicable if any.
- 3. Work Completion: The work execution shall start within the response time of @ 04 Hrs from the date & time of intimation to the agency by MSETCL. The timing will be calculated from the time of mobilization of your fleet and workmen's for work execution. Intimation regarding start of work shall be given to concerned authority. You will have to attend for work execution at respective site well within further 08 hours after the expiry of initial 04 hours. Thus the total site response period is @ 12 hours only. Since the work is also to be executed in naxal prone / naxal affected areas of Gadchirolli District viz. Etapalli , Allapalli , Sironcha , Jimalgatta Etc , the agency should have local base / office for man & material for work execution i.e. agency will have to submit documentary proof of local office @ Chandrapur city . The acceptance of response time as above is essential.If agency fail to submit the proof of local base/office with qualifying bid ,their bids will not be considered.
- 4. Watch & Ward during Execution: You will have to take over the site for Work Execution from the concerned SDO/ Substation Incharge in writing. During the execution of work the complete responsibility of the watch & ward of material supplied by the agency / MSETCL will be the responsibility of the Contractor. For any loss due to theft or any other reason, the contractor will have to make good for all the material or pay equivalent amount as per present Market Rate.
- **3** The work shall be completed within minimum possible time but not more than time specified by the C.A at individual site locations from the date of handing over of site. MSETCL reserves right to continue this contract for further period of six months at the same rate and other terms of contract. The agency shall have to carry out the work during the extended period; otherwise, the work will be got done through another agency at the risk and cost of the agency.
- 5. Safety:- The contractors should provide all safety equipment / Tools & Tackles required for the work to his workers. If any accident occurs due to non-supply of these equipments or careless handling of equipments, the same shall be to the contractor's risk and cost. The contractor must maintain one first aid box in safe custody during the execution of work at site. MSETCL will not be responsible for any negligence on the part of contractor or contractor's personnel. It is the sole responsibility of the contractor to insure all his workmens. The safety of working personnel's should be given utmost priority while work execution.
- 6. The work of transportation may also have to be executed in core naxal affected areas of Gadchiroli District, hence the bidder/contractor is required to take all necessary precautions while executing the work in such areas. All employees of contractor shall be insured against threat to life (life insurance policy). It is the sole responsibility of the contractor to insure all his workmens. The safety of working personnel's should be given utmost priority while work execution. If required the help of local police / forest officials should be taken. All the required local liaisoning will have to be managed by the contractor it self.
- 7. Damage to Persons & Property:- You will have to indemnify the MSETCL against any claims regarding any injuries or damage to any person, material or physically damage to any property whatsoever which

may arise out of or in consequence of the execution of work. During execution of work any damage / loss to MSETCL's property occurs will be recovered from your bill as per the prevailing market cost.

8. Contractor's Scope:-

- a) Sufficient Manpower for execution of work will be arranged.
- b) Technical Expertise.
- c) Senior Tech. Expertise to supervise the work at site.
- d) Tools and tackles.
- e) Residential accommodation to the Contractor's staff.
- f) All miscellaneous material required for successful execution of work.
- **9. Supervision**: The work will be under the Supervision of concerned Engineer Incharge or any other Engineer/ employee specially deputed by Executive Engineer, EHV (O&M) Division Wardha.
- **10. Penalty**: If the work is not completed within stipulated period **penalty** @ **1/2% per week** of total order amount to the maximum of 10% of contract value will be deducted from your bill.
- **11. Guarantee/Warrantee:** The Transporter shall be responsible for safety of the material & equipment received by him. All formalities related to RTA, Toll Tax, B&C will be at contractors risk & cost. He will be responsible for the damages & road culverts. Any penalty from the said authority i.e. RTA, B&C will be at contractors risks & Cost. MSETCL will not be responsible for such penalty.

12. Scope of Work:- As per Schedule – A.

- **13.** Price Variation: Price Variation is not applicable to this tender.
- **14.** Any Loss to MSETCL property during work execution will be at the **cost & risk** of contractor.

15. Submission of Bills: - Bills shall be submitted to respective sub/stn Incharge or sub/Div. Incharge.

- a. The bills will be submitted by the agency after successful completion of work.
- b. Bills submitted without proper and complete details, will not be admitted for payment and shall be returned at the risk and cost of contractor. The delay caused in processing the bills shall be to the contractor's account. All original documents or certified Xerox copy shall be attached to bill.
- c. The payment of the bills shall be made by the office of the Executive Engineer after effecting recoveries, if any. Payment shall be effected to the contractor at the rate accepted in the rate Schedule on the basis of actual work.
- d. Whenever any recovery towards losses/damages/shortages etc. is applicable the same shall be recovered as assessed by the Engineer-In-Charge of the Substation/Sub Division.
- 16. Payment: 100% payment as per actual within 30 days will be done after satisfactory completion of work and certification from concerned Substation Incharge in that respect. However release of payment may depend on availability of funds. Contractor shall submit the bills in triplicate along with joint inspection report to the concerned Substation Incharge for the actual work done under this contract. The concerned Substation Incharge will record the Bills in M.B. and will punch the bills received from contractor in ERP SAP system and prepare the SERVICE ENTRY SHEET for the bills within 03 days. Duly recorded the bill in M.B with SERVICE ENTRY SHEET No. shall be submitted to Division Office for scrutiny and payments. Payment will be done as per actual.
- 17. Before quoting the rates, the contractor may visit individual site locations, switchyards for accessing the actual scope of work.

- 18. Termination of Contract:- The undersigned reserves the right to accept or reject the tender in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 03 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactorily / or not able to execute the work as per Order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- **19. Performance of bidder**:- The performance of work of the bidder in the past or for ongoing works/projects will be evaluated. It is essential for any bidder to have good/satisfactory work performance track record. If it is found that any bidder is found defaulter for poor / slow work performance or penalty is imposed for delay in works / convicted in court for poor performance, for fraudulent practices etc, found producing fake supporting documents or creating obstructions in MSETCL's works, such bidders will be straightaway termed disqualified even if they have submitted all required documents. The discretion of U/s will be final and binding on the bidders.
- **20.** Awarding of contract:-The Company does not bind itself to award the contract to the lowest bidder. Eligibility of the bidder, submission of all documents, past track record and work performance will carry due weightage while arriving at the decision. The bidder should not quote conditional rates related to quantity of work. The Company reserves the right to award the contract to more than one bidder by splitting the tendered quantity in the interest of MSETCL and may cancel the tender at any stage in the interest of MSETCL due to administrative reasons.
- 21. It is mandatory to submit all documents as per the qualifying conditions / requirements. The qualifying conditions will not be relaxed at any stage. Hence it the responsibility of the bidder to submit correct & relevant documents.
- 22. In normal cause, the interpretation of the Executive Engineer EHV (O&M) Division Wardha on any matter or decision given by him on any disputable point will be final and binding on the contractor. This is an e Document and does not require any Signature.

- a) Average Annual financial turnover during the last 03 years, ending 31st March of the previous financial year, should be at least 60 % of the estimated cost. In support of this the bidder shall submit the annual audited report by the statutory Auditor in case of company & by the chartered Accountant where accounts are not required to be audited under any law.
- b) The bidder must have experience of having successfully completed similar works (similar works means transportation of EHV Transformers /Reactors/heavy critical electrical equipments along with allied material) & all EHV Substation/Lines materials including loading, unloading, winching& staking during last three years from the schedule date of submission of tender/RFX having

 - 3. <u>One</u> similar completed work of transportation of EHV Transformers /Reactors/heavy critical electrical equipments along with allied material each costing not less than the amount equal to 80 % of the estimated cost.

The contractor shall have experience of transportation of EHV Transformers /Reactors/heavy critical electrical equipments weighing at least 40MT & above for distance 50km or more . The experience certificate from the authority of the rank of Executive Engineer OR above in MSETCL or equivalent shall be submitted.
